Los Alamitos Unified School District FIRST INTERIM REPORT 2023-24

Interim reports are mandated to validate a school district's financial solvency by examining and reporting actual revenues received and funds expended at two specific points during the fiscal year and by projecting fiscal activity through the end of the current fiscal year and two subsequent years. This First Interim Report looks at actual revenues received and funds expended from July 1 through October 31, 2023.

Based upon projections for the current and subsequent two fiscal years and using the assumptions presented below, the District is able to certify it will meet its financial obligations for the current and subsequent two fiscal years.

State Budget Overview

The 2023-24 State Budget was signed on time by Governor Newsom on July 10, 2023. The Governor signed the Education Omnibus Trailer Bill (SB 114), which provides the statutory 8.22% Local Control Funding Formula (LCFF) cost-of-living adjustment (COLA). Subsequently, the state legislature adopted Senate Bill (SB) 141, which introduces small changes to the budget. The most significant of these changes include language to address emergency closure situations for the Expanded Learning Opportunities Program. Additionally, it clarifies that the new early enrollment Transitional Kindergarten (TK) classroom enrollment and the adult-to-student thresholds are specific to individual classrooms, rather than averaged across each school site like the other TK requirement.

The major K-12 funding provisions included in the 2023-24 state budget:

- \$1.1 billion reduced funding to the Learning Recovery Emergency Block Grant, which amounts to approximately a 14% reduction on the 2022-23 fiscal year.
- \$200 million reduced funding to the Arts, Music, and Instructional Materials Discretionary Block Grant, which amounts to approximately a 6% reduction of the original amount.
- Special education base rate increases to approximately \$887.40 per funded ADA.
- Requires TK classrooms to maintain a ratio of 1 adult to 10 students in 2025-26 with the intent to provide funding to pay for the costs associated with lower classroom ratios.

Review of District's Assumptions of the 2023-24 Budget at First Interim

Revenues:

- The LCFF funding comprises the following assumptions:
 - The Base Grant which is funded by grade span based on the District's current or prior year P2 ADA, whichever is higher. For 2023-24, the funded average base is approximately \$11,684 per ADA and we are anticipating using the three prior year average ADA as we are declining in enrollment.
 - K-3 grade span adjustment of 10.4% on the base grant amount.
 - 9-12 grade span adjustment of 2.6% on the base grant amount.
 - Supplemental Grant equal to 20% of the base grant amount adjusted by the District's percentage of English Learners (EL) and Free and Reduced-Price Meals (FRPM) unduplicated count which is 17.50% for Los Alamitos Unified School District which equals to \$3,507,850.
- The cost of living adjustment (COLA) is projected at 8.22%.
- Based on enrollment estimates as of October 2023, we are projecting our actual 2023-24 ADA to be 8,493.58, not including County ADA, a decrease of 1.01 ADA over the prior year. However, based on the enacted state budget, funding will be based on the prior three-year average ADA of 8,938.67, not including County ADA.
- Increase in Special Education AB602 funding to the base from \$820 to \$887 per ADA is included at First Interim.
- A one-time Arts, Music & Instructional Materials Block Grant and the Learning Recovery Emergency Block Grant of \$8.8 million is included at First Interim.
- A transitional kindergarten base grant adjustment and add-on of \$3,044.23 per ADA is included at First Interim.
- Unrestricted lottery income is projected at \$177.00 per annual ADA and restricted lottery income is projected at \$72.00 per annual ADA.
- STRS on behalf contribution state revenue of \$6,354,212 is included at First Interim.

Expenditures:

- Total salaries increase by \$577,033 from Adopted Budget due to staffing changes to accommodate increase in enrollment.
- The current cost of salary step and column are included.
- Statutory benefits (Medicare, Social Security, Workers' Compensation, State Unemployment insurance) are adjusted accordingly with increased salary costs. The cost of STRS on behalf contribution of \$6,354,212 is included at First Interim.
- Health and Welfare costs are estimated at \$18,561 per employee for 2023-24 at First Interim which is an increase of \$2,658 per employee from 2022-23.
- Budget for Books and Supplies increased by approximately \$4.7 million due to allocation of discretionary carry over funds and additional one-time funds.
- Budget for Services and Other Operating Expenses increased by approximately \$6.9 million due to allocation of discretionary, restricted carry over funds, and allocations of one-time funds.
- Budget for Capital Outlay increased by \$255,835 due to allocation of carry over funds.

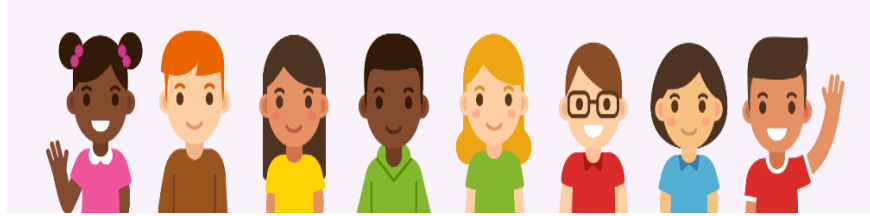

- ✓ Unrestricted lottery income is projected at approximately \$177 per annual ADA. Restricted lottery income is projected at \$72 per annual ADA.
- ✓ A transitional kindergarten base grant adjustment and add-on of \$3,164 per ADA is included.
- ✓ The ongoing Expanding Learning Opportunity Program funding is included.

- ✓ Workers' Compensation is projected at 2.429%, an increase of 1.05% over the 2024-25 rate.
- ✓ STRS rate is projected at 19.10%, no change over the 2024-25 rate.
- ✓ PERS rate is projected at 28.30%, an increase of .6% over the 2024-25 rate.
- ✓ The projected increase in health benefit compensation costs is included at \$22,869 per covered employee.
- ✓ The Books and Supplies budgets are projected based on revenue anticipated.
- ✓ The Services and Other Operating Expenses are projected based on revenue anticipated.
- ✓ Capital Outlay expenses have been adjusted.
- ✓ An interfund transfer of \$1 million from the General Fund to the Deferred Maintenance Fund (Fund 14) is projected for 2025-26.
