6. Building Reports

- 6.1 Elementary Building Report
 - a. Student Conflict Awareness Assembly

Dr. Wilson said based on a DASA school climate survey: Mr. Auffrey ran two assemblies which focused on: 1. Responsible use of social networks and 2. Peer conflict/bullying. He made this fun using a survival theme, getting all of the students engaged and involved. I followed up with some of our intermediate parents and they said that their children did come home and discuss many of these talking points with them

b. Winter PBIS (Positive Behavioral Intervention Support Efforts)

Dr. Wilson said that we ran several programs this winter in order promote a safe and orderly school environment as follows:

- a. Bucket Filling: this is the theme of tomorrow assembly: It is based on Carol McCloud's book: and is a metaphor: are hearts are like buckets and when we are kind to others we are filling their buckets and when we are unkind we dip into their buckets, and our friends with empty buckets may have behavior problems etc. Mrs. Radomski reads student bucket fillers at the end of the day and they sound like "I would like to fill Tommy's bucket because he played with me when no one else would." These are then displayed on our bucket filling bulletin board
- b. Under Guidance Counselor Amanda Woodward's leadership: we have the friendly helper's anti-bullying club: they wear buttons/pins at lunch and help students who are feeling isolated sitting alone etc. At recess their role is the same.
- c. Bus of the month award: beginning in January Mrs. Price has watched bus videos on a weekly basis and rewarded the bus that has students who are most often following the Marauder Way: Mr. Green's Green Bus and Mr. Kurgan's orange bus have both been awarded bus of the month certificates and prizes.
- d. At a winter PBIS meeting our team analyzed the discipline data and noticed that it spiked in January. We launched a January booster called going green in january. Every one of our teachers has a classroom behavior plan that usually involves a green red yellow system. Any child who stayed on green for the entire month had their name put into a drawing and one student per grade level won a pair of Utica College Hockey tickets.

c. Regional Report Card Committee

Dr. Wilson said this idea was sparked at an Elementary Principal's meeting. Some of us: Westmoreland, Whitesboro, Waterville, Oriskany, and Sauquoit, are conversing with our teachers, and then meeting tomorrow to discuss what common language do we want on a report card: do we want to move towards standards based grading, do we want to move to a 1234 grading scale? Currently Mindex provided us canned standard based grading templates and exemplars: I have met with my teachers, received some feedback: and will be meeting with my colleagues tomorrow to see what the next steps are. If somehow we can create a regional report card: this would allow cohesiveness for our transient youth: as well as interprofessional conversations and collaborations among administration and teachers.

d. Projected Enrollment 2014-15

Dr. Wilson said that right now the largest classes are 6th grade: it is her understanding that when this class gets to the Jr. High it will be split into three sections. Knowing this, and knowing that the overall climate of a classroom is more conducive to learning with fewer students, she is advocating for another teacher at the elementary school. She said she spoke with Ms. Houghton and she doesn't believe the budget will support it at this time. However another Academic Intervention Services teacher particularly in a part time teacher in Math would be helpful, and an afternoon bus aide.

6.2 Secondary Building Report

a. Projected Enrollment 2014-15

Mr. Spost read the projected enrollment for the Jr. Sr. High School as follows: 12th grade - 46, 11th grade - 45, 10th grade - 48, 9th grade - 28, 8th grade - 54, and 7th grade - 48. Approximately 269 students are in grades 7-12 based on rolling current grade enrollment levels into the next consecutive grade. We have some of the classes with their projected enrollment, but it is incomplete at this juncture. We are still in the process of meeting with students (mostly upperclassmen) individually to discuss schedule so the numbers at this point are not accurate. If we start taking options off the table for students it will cause a ripple effect and numbers will change. He said he does know that the Board is looking at numbers to see if a class should be offered. If we have only a cluster of four or five kids that were accelerated in 8th grade and are now eligible for AP Math as 12th graders, do we say to them and their parents, "Sorry, although you are some of our best and brightest, worked very hard and challenged yourselves, we don't have any math course to offer you." He is proposing maintaining the same level of staffing we have in all departments and continue the opportunities that we have provided in the past to all students. It does not make any sense to me to have fewer options available to students that will be graduating in the future. Our High School program right now is competitive and his goal is to maintain it. Our charge is to get students ready for a more competitive and complex society and this will not happen by giving them fewer options. He understands your charge to be as cost efficient as possible and there may be a way to accomplish all of this and lower overall cost of programming. This would involve discussion of specific personnel, though.

b. STAR Benchmarching

Mr. Spost reported that there were two weeks in February during which we administered STAR testing for both ELA and Math. These tests are designed to measure how much students grow as a result of a teacher's instruction. We have found at the secondary level that their assessments do not always correlate well with the content taught in the classes. For example with ELA, The STAR test mainly measures reading comprehension with no writing component and the ELA Regents exam required for graduation is seventy-five percent writing. The math also does not correlate very well with the content taught in classes. Students also have no vested interest in doing well. How much effort would you put in to a test if you knew it didn't count for you? These are some of the hurdles we are dealing with. He was hopeful that we can correct some of these problems as we renegotiate APPR. It is his goal to reduce unnecessary testing and replace it with meaningful testing as much as possible and also save the district money at the High School level by not relying on third party vendors. BrainHoney, if it is an asset to teachers will be embraced and used as a resource on a regular basis. If it is a simple add on with limited benefits, he would not expect many teachers to opt in.

c. Evening Internet Safety/Cyber Bullying Workshop

Mr. Spost said on the 13th of February we had an Internet Safety and Cyberbullying program in the evening for parents. The presenter was Greg Auffrey, who he refers to as our Safe School Specialist from BOCES that is in district once per week. He presented Web safety tips for parents, safe facebook practices, the fact that online footprints are forever, issues with snapchat, revealing too much information, and also discussed some apps available to monitor teenage electronics. He also covered the cyberbullying and Dignity for All Students Act. There were around 40 parents in attendance as well as 20 or so students on hand that were there for extra credit. Door prizes were awarded from Trio's Pizza, Symeon's, Hapanowicz, Pizza Boys, Harley-Davidson, and gift cards from Walmart that were generously donated by PTSO. Thank you letters were printed up and over twenty students signed each letter. He is sure businesses will be proud to display them.

d. Jr. – Sr. High School Musical.

Mr. Spost said that the Jr. Sr. High School Spring Musical will be held on March 20th through March 22nd. The show is *Bye Bye Birdie* and students are very eager to perform and display the hard work that has been put into it for the last several months. On Thursday the 20th we will have a Senior Citizen Dinner Theatre Performance beginning at 4pm. Senior performance with the dinner is \$8 and without the dinner it is \$6. On Friday the 21st and Saturday the 22nd the show will begin at 7:30pm. Ticket prices for adults are \$8 and ticket price for seniors and student are \$6. Tickets can be purchased from Mrs. Lovecchio or the HS Office starting March 10th.

7. Superintendent's Report

1. District K-12 Current Enrollment

Ms. Houghton reviewed with the Board a chart that showed the district's current K-12 enrollment. We have 594 students, with 19 attending special education or alternative programs outside the district, 315 students attending our grades K-6 Elementary School, and 260 students attending our grades 7-12 Jr.-Sr. High School.

2. 100th Day/Centennial Update

Ms. Houghton gave each Board member a printed program from the elementary and secondary school assemblies that took place on Thursday, February 13th. Students from Kindergarten, 6th Grade, 7th grade, and 12th grade presented historical information about our school district. Mr. Lachut and Mr. Wegrzyn opened the 1957 time capsule and Ms. Houghton shared the contents of the capsule with the audience. Ms. Houghton reminded everyone that on Saturday, March 29th beginning at 1:00 p.m., there will be alumni basketball games at Beekman Gymnasium, followed by a 7:00 p.m. Gala Celebration at Twin Ponds Golf & Country Club. Tickets for the evening event are \$35.00 each and can be purchased through Mr. Spost or Mrs. Zogby at school, or by contacting foundation@newyorkmills.org.

3. Preliminary Architect Meeting

Mrs. Houghton said that tomorrow night, the Board will be meeting with Hunt Engineers, Architects and Surveyors to establish a schedule and preliminary plans for a capital project that will include increased safety and security, technology infrastructure to support the security systems as well as our instructional program, improvements to our bus/car rider drop off area, repairs to Beekman and the track, and enlargement of our K-12 cafeteria so that students can eat earlier and have time to finish their lunches. The public is invited to attend this meeting.

4. Legislative Advocacy Efforts

Ms. Houghton reported that she just returned from Albany, where members of the New York State Council of School Superintendents advocated for additional school funding and reductions in mandates for schools. She also thanked Jackie Edwards and Gail Rice, who will travel to Albany with her this weekend to attend the New York State School Boards Association Capital Conference and Lobby Day.

5. Annual Professional Performance Review Plan

Ms. Houghton shared that the Professional Education Committee (PEC) continues to work toward making changes to our Annual Professional Performance Review (APPR) plan for 2014-15. We have discussed changing the teacher rubric from the NYSUT format to Danielson 2007. We have also been discussing at length the use of various assessments to measure student progress. Once final decisions have been made, we will bring the plan to you for approval prior to submitting it to the NYS Education Department.

6. Budget Workshop

Ms. Houghton and Mrs. Stamboly provided a budget workshop presentation to the Board and public using the following slides:



Propositions and the Tax Cap

Chapter 97 allows separate propositions:

Nothing in this section shall preclude the trustee, trustees, or board of education of a school district, in their discretion, from submitting additional items of expenditures to the voters from submitting propositions pursuant to sections two thousand eight and two thousand thirty-five of this part; provided however, except in the case of a proposition submitted for any expenditure contained within subparagraphs (i) through (iv) of paragraph I of subdivision two of this section, if any proposition, or propositions collectively that are subject to a vote on the same date, would require an expenditure of money that would require a tax levy and would result in the lax levy limit being exceeded for the corresponding school year then such proposition shall be approved if sixty percent of the votes cast thereon are in the affirmative.

7. Capital Reserve

Ms. Houghton told the Board that she would be bringing a Capital Reserve resolution to the Board at their next meeting for their approval. We are asking that the Board vote to establish a Capital Reserve to be funded at an amount up to \$1,000,000. We are planning to move money from the Repair Reserve into the Capital Reserve. We can also add to the reserve with any funds available at the end of each fiscal year. The Capital Reserve Fund will assist us in reducing the taxpayers' share of future capital projects.

Mr. Szczerba comment we always hear from political leaders that we support the troops but when men and women return and programs are proposed to help to educate them our congress says no. He hoped that we don't follow that tract. He also asked how many veterans live in the New York Mills School District and how many are paying taxes. What are the ranges of the taxes?

Mrs. Stamboly responded there are 255 veterans that are taxpayers in the district and there is a range of taxes.

Mrs. Gale mentioned that the New York Mills Teachers have been without a contract for 612 days. There are new standards and increased accountability. The New York Mills Teachers Association wants a fair and equitable contract and invites the board to the negotiations table to expedite the process.

Mrs. Hamarowicz spoke about class size. She has 27 students in her class. You can give her BrainHoney but you cannot give her the time she needs to spend with individual students. She cares about the kids but cannot get to every one of them. The past few weeks she has had a student teacher and that was the only time she has been able to help every student.

Dr. Wilson made an appeal for putting in three sections to benefit kids. It will make it better for the students.

Mrs. Porcelli had concerns about files and student information stored in clouds and the safety of them. With STEM, where are the arts in all that? Having been an English Major and a Biology Minor she was concerned that we don't lose what we have about the arts. This business about the veterans, she said her father as a WWII veteran, he was not in combat; her brother was a Vietnam veteran. When she sees a vet she says "Thank you". There are things you can do that are not taxpayer-costly. One of things she found is that Veteran's Hospitals appreciate Valentines. There is a lot we can do. She does support veterans but can see the difficulty regarding taxes. The 100 Year Assemblies were

great. She was so impressed with how our kids presented themselves. The 100 Year Centennial Committee is working in partnership with the community. It is not easy to do. We are trying very hard to work collaboratively. Things are in process that will include the community.

Mr. King asked where the architect meeting is.

Ms. Houghton replied, "Right here in the library."

Mr. King said Arts Fest is coming up. If you would like to share skills, MAD Boosters is hard at work getting it ready. He thinks Dr. Wilson needs three teachers for a more manageable classroom size for students. He also asked by why budget code B2110, textbooks, is down by 29%.

Ms. Edwards asked Ms. Houghton or Mrs. Stamboly to get back to Mr. King regarding this budget question.
