#### District stays under tax cap for eighth year

On Tuesday, April 9, 2019, the Caledonia-Mumford Board of Education unanimously adopted the school district's 2019-2020 budget. On May 21, 2019, district residents will vote on the proposed 2019-2020 school budget of \$18,439,261, a budget to budget increase of 1.70 percent and a proposed tax levy increase of 1.99 percent. In addition to the school budget, residents will also elect two candidates for the Board of Education and vote on the purchase of two small school buses.

Caledonia-Mumford's maximum allowable tax levy limit for next school year is 2.0 percent. As you can see, the 1.99 percent proposed tax levy increase is slightly below the state's allowable limit for the eighth straight year. More importantly, homeowners that are eligible for the STAR program will receive a rebate check (equal to the school tax increase for the past eight years combined) from New York State sometime in the fall of 2019.

Board President, John Bickford said, "From the onset of the development of the 2019-20 school budget, it was the Board's intention to develop a budget that was educationally sound, invest in our students and is fiscally responsible to the tax payer." The budget that district residents are being asked to consider fulfills the District's mission and vision, stays within the property tax cap levy and is responsible in terms of the long-term fiscal viability of the school district. The Board believes that the proposed school budget maintains an educational program that will continue to be a source of pride for the community.

Vice President, Arnold Rychlicki, said, "This year's budget development was much more difficult than in previous years and our proposed budget is tighter than ever before. More importantly, the proposed budget will meet students' needs from Pre-K through 12th grade."

#### The proposed 2019-2020 school budget will:

- Provide support to maintain its core Pre-K-12 academic programs.
- Provide funding for additional Advanced Placement courses in math, art, psychology and science, while maintaining the current Advanced Placement courses. In addition, college level courses at Genesee Community College (GCC) and Rochester Institute of Technology (RIT) will continue.
- Preserve all art, music, co-curricular activities and the athletic program. Furthermore, additional elementary and middle school enrichment opportunities will exist as well as the addition of the indoor track team and unified sports program at the secondary level
- Provide funding for a full-time School Resource Officer.
- Provide funding to implement year two of the District's Strategic Plan Initiatives.
- Adhere to the State imposed tax levy cap.
- Preserve the full-time English as a New Language teacher position.
- Maintain small class sizes.
- Include resources to support the Olweus Bullying Prevention Program and resources.
- Include additional funding for instructional materials for ELA, science and social studies curriculum.
- Include funding to implement two senior high electives in physical education and social studies.
- Continue the district's commitment to the implementation of a multi-year Technology Plan.
- Appropriate funding to provide high-quality transportation services for district resident children.
- Include funding to develop a long-term instructional and financial strategic plan.
- Replace the Hamilton Sports Complex scoreboard that was

- damaged beyond repair from a recent wind storm and replace and upgrade energy efficient PTAC (Packaged Terminal Air Conditioning/Heating) units in the middle/high school nurse's office.
- Protects the community's investment in facilities, infrastructure and programming.
- Creation of new MS/HS student clubs- Debate Club and Art Club.
- Provides funding for summer school reading intervention program for grades 4-8.
- Provide funding to support increased professional development opportunities for staff.
- Meet legal mandates and contractual obligations.
- In order to meet the increased costs in special education and homeless students the District will increase its dependency on reserves by \$50,000.

In addition to the proposed school budget (Proposition #1), voters will be asked to vote on Proposition #2, which seeks your approval to purchase two small buses; one handicap accessible bus and one 30 passenger bus not to exceed \$130,000. Busses will be financed over five years to coincide with the district's receipt of Transportation Aid.

Please take time to review the budget information in this newsletter and the information located on our website www.cal-mum. org. I thank you for your support and investment in our students and look forward to seeing you at the polls on May 21, 2019 from 12 p.m. to 9:00 p.m. in the District Office.

We invite you to attend the Annual School District Budget Hearing on Tuesday, May 14, 2019, at 7:00 p.m. in the MS/HS auditorium. Immediately following the budget hearing, candidates for the Board of the Education will provide a brief statement and answer questions from district residents. Please join us.

Q. What is the history of voting outcomes, tax levy and budget-to-budget change for the district?

- Q. What is Caledonia-Mumford's graduation rate?
- A. Caledonia-Mumford's 2018 graduating class had an impressive 96% graduation rate but what was even more impressive was that 71% of our students graduated with an Advanced Regents Diploma. This diploma includes students passing the course and the following Regents exams: Comprehensive English, Mathematics (All three), Global History, US History, Science (One physical and one life science) and Language other than English.
- O. How much is the proposed budget?
- **A.** The proposed budget is \$18,439,261.
- Q. What are the major items that increased from the current year to the 2019-20 year?
- A. The major items that have increased are special education and transportation costs.
- O. How did the district achieve savings in the budget?
- A. The District achieved savings in several areas. These include employee retirement costs, healthcare costs and the difference of salary between a retiring veteran teacher and new teacher to the district.
- Q. What is the proposed tax levy increase for the 2019-2020 school year?
- A. The proposed tax levy increase for the 2019-2020 school year is 1.99%. Caledonia-Mumford's allowable tax levy cap is 2%.
- Q. Why purchase buses each year?
- A. The district purchases a bus or two each year as part of its replacement schedule. Based on our current schedule, our buses will be replaced after approximately 13 to 16 years of service and have been driven 120,000 to 140,000 miles. Continuing our current strategy will sustain our fleet and provide for a

- systematic update of our fleet configuration. Did you know? The district is reimbursed for 78.6% of a bus purchase cost.
- Q. What happened to the State's 2% tax cap?
- A. In 2011, the State signed into law a property tax cap. It was falsely presented as a 2% tax cap which was popularized by the media. In reality the property tax cap is 2% or the Consumer Price Index (CPI) whichever is lesser. The property tax cap calculation excludes eligible exemptions such as retirement system expenses greater than 2%, capital debt and court orders. Caledonia-Mumford's allowable tax levy cap is 2%. The proposed tax levy increase is within the District's allowable limit.
- Q. I am still confused with the increase in property assessments. How will this affect my school taxes?
- A. The school is not involved in any increase/decrease with your property assessment. If you have questions with regard to your assessment, you should call your town assessor.
- Q. What is Cal-Mum C.S.D.'s response to challenges?
- A. To help off-set the loss of revenue through state aid cuts, school officials continue to apply for grants and seek efficiencies. Specifically, the district has earned Carol White Grant (PEP) \$598,000-two year grant, Virtual AP Grant (provides free of charge AP classes on-line for students), Teacher Center Grant, Records Retention Grant, NYSERDA Grant for school bus heaters, P-Tech Grant, National Grid Efficiency Grants and Various Livingston County Business Education Grants. In addition, the district has implemented a single bus run to reduce transportation expenses. Moreover, the District has eliminated 27 Full-Time Equivalent positions in the district over the last seven years.

- Q. How much lottery aid does the C.M.C.S.D. receive from the state of New York?
- A. The school receives about \$ 1.3 million from NYS Lottery purchases.
- Q. What happens if the budget is not approved by voters?
- A. If the budget is not approved by voters, the Board has three options: Present the same budget to voters for a second time, present a revised plan budget to voters or adopt a contingency budget. If the proposed budget is defeated twice by voters, the district must adopt a contingency budget. Under the new property tax cap law, a school district that adopts a contingency budget cannot increase its tax levy by any amount.
- Q. What is fund balance? How is it used?
- A. A fund balance is a reserve much like a homeowner's savings account. When district expenses are less than what was expected or revenues are higher than expected the money contributes to the fund balance.

Districts may use fund balance each year as a revenue in the budget to minimize spending cuts and stabilize tax rates. The money is also used for unforeseen expenses throughout the year. By law, a district's unrestricted fund balance may not exceed 4% of the next year's budget.

Just as homeowners are careful not to use up their savings accounts, districts also must plan carefully how to use their fund balance to ensure it does not run out.

- Q. How does Caledonia-Mumford's spending compare to other schools?
- A. Caledonia-Mumford's spending for general education students is \$10,724 per pupil compared to similar school districts of \$11,230 per pupil. Caledonia-Mumford spends \$28,426 per special education pupils compared to similar schools' spending of \$31,577. (last years—waiting on State ed.)
- Q. Will the 2019 Capital Project increase my taxes?
- A. No. There is no future tax impact on residents.

## Where do your tax dollars go?

This brochure identifies the line item allocations of District spending. State law requires the District to analyze spending by breaking our school budget into three basic components: Administrative, Capital, and Instructional Programs. Referred to as a three-part budget, this analysis shows another way of looking at District spending.

#### Administrative – Total Dollars: \$1,998,752 or 10.84 %

The Administrative component consists of the following expenditures:

#### Capital – Total Dollars: \$3,175,430 or 17.22%

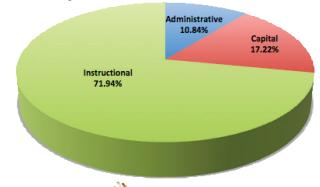

- · Costs associated with community use of school facilities

#### Instructional Program – Total Dollars: \$13,265,080 or 71.94%

The Instructional Program component consists of the following expenditures:

- Salaries and benefits for all teachers and teacher aides
- · Salaries and benefits for bus drivers
- All transportation expenses including contract transportation
- BOCES Special Education and Occupational Education costs
- Instructional supplies, textbooks, computers, and software expenses
- Costs for extra-curricular activities and interscholastic sports

### Proposition #1 – Budget Resolution

BE IT RESOLVED, that the proposed budget of expenditures for the fiscal year 2019-2020 in the amount of \$18,439,261, and for the purposes shown in statement of estimated expenditures adopted by the Board of Education, be one and the same, hereby is approved and the amount thereof shall be raised by a levy of a tax upon the taxable property of the school district.

#### Proposition #2 – Bus Resolution

RESOLVED, that the Board of Education of the Caledonia-Mumford Central School District is hereby authorized to undertake the acquisition of one(1) handicap accessible school bus at an estimated maximum cost of \$72,000, AND one (1) 30-passenger school bus at an estimated maximum cost of \$58,000, all at at an estimated maximum aggregate cost of

\$130,000, less trade-in value, if any, and that such costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments; and, in anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$130,000 shall be issued, or the school district may enter into an installment purchase contract if the Board of Education determines that it is in the best interest of the school district to finance the purchase in that method.



## NEW SCHOOL PHYSICAL MANDATES FOR THE 2019-20 SCHOOL YEAR

New York State law requires a current health examination for all students entering the school district for the first time and when entering Pre-K through Grade 11. The grade levels listed are slightly different than in the past. Please read this carefully and provide the school nurse with proof of a health examination for any child this pertains to.

The examination must be completed by a New York State licensed physician, physician assistant or nurse practitioner. A copy of the health examination must be provided to the school within the first 30 days from when your child first starts at the school, or when your child starts any of the grades previously listed. The school will contact you if a copy of the examination has not been received within the 30 days of entering the 2019-20 school year.

#### SIGN UP FOR A SCHOOL PHYSICAL

Any student going into grades 7, 9, or 11, and/or interested in participating in a school sport next year, will need to provide a current physical to the school nurse. The school physician will be at the school to provide physicals on the following dates:

- Middle School May 22
- High School May 29

If you want your child to have a physical at school have them sign up in the health office with Mrs. Geer.

#### **IMMUNIZATION REQUIREMENTS**

#### For incoming 6th graders:

New York State Public Health Law, section 2164 requires students enrolled in the 6th grade and are 11 years old to be immunized against Tetanus, Diptheria and Pertussis (Tdap booster) and two doses of the varicella vaccine.

Please have your primary care physician send an updated copy of your child's immunization record which includes the Tdap and varicella vaccines before the start of the 2018-19 school year. They will not be allowed to enter school without it.

If your child is not yet old enough to receive the Tdap immunization, please notify the school nurse of the date your child is scheduled to receive it.

## For students entering grades 7, 8, 9, 10 and 12 during the 2019-20 school year

Students entering grades , 8, 9, 10 and 12 will be required to be fully vaccinated against meningococcal disease according to the recommendations of the Advisory Committee on Immunization practices (ACIP). The ACIP recommend that all adolescents receive a first dose of MenACWY vaccine at 11-12 years of age and a booster dose at 16 years in order to boost their immunity during the years at which they are at greatest risk of meningococcal disease. If the first dose was administered on or after their 16<sup>th</sup> birthday, a booster dose is not necessary.

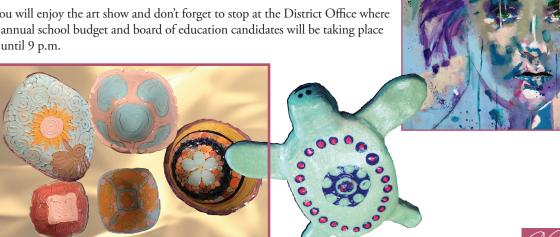

The art show will take place in the Middle School Music Suite (exhibits in both the choral and instrumental rooms) from 5 p.m. to 7 p.m.

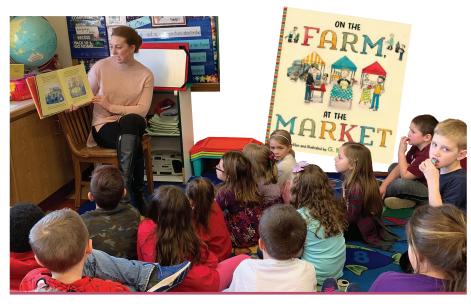

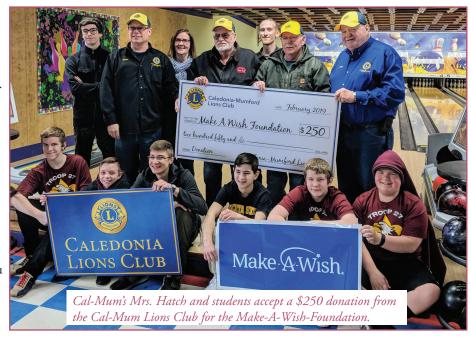
The Raider bowl-a-thon raised \$625 for the Make-A-Wish Foundation!

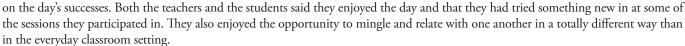
## Student and Staff Wellness Day in the Middle School

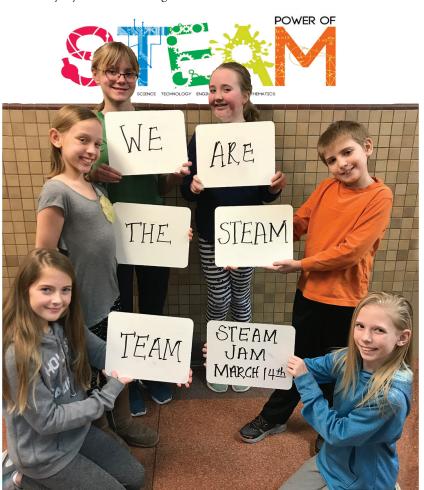
Middle School Principal Mr. Paul Estabrooks said this day has been one of the most anticipated events of the year since he started the wellness day two years ago.

Instructional Expenditures for General Education are K-12 expenditures for classroom instruction (excluding Special Education) plus a proration of building level administrative and instructional support expenditures. These expenditures include amounts for instruction of students with disabilities in a general-education setting. District expenditures, such as transportation, debt service and district-wide administration are not included.

The pupil count for General Education is K-12 average daily membership plus K-12 pupils for whom the district pays tuition to another school district. This number represents all pupils, including those classified as having disabilities and those not classified, excluding only students with disabilities placed out of district. Pupils resident in the district but attending a charter school are included. For districts in which a county jail is located, this number includes incarcerated youth to whom the district must provide an education program.

Instructional Expenditures for Special Education are K-12 expenditures for students with disabilities (including summer special education expenditures) plus a proration of building-level administrative and instructional support expenditures. District expenditures, such as transportation, debt service and district-wide administration are not included.

The pupil count for Special Education is a count of K-12 students with disabilities for the 2016-17 school year plus students for whom the district receives tuition from another district plus students for whom the district pays tuition to another district. Students attending the State schools at Rome and Batavia, private placements and out-of-state placements are included.

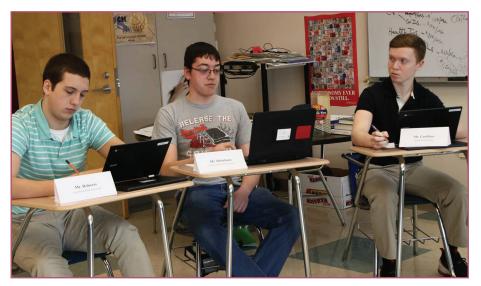
Instructional Expenditures Per Pupil is the simple arithmetic ratio of Instructional Expenditures to Pupils. The total cost of instruction for students with disabilities may include both general- and special-education expenditures. Special-education services provided in the general-education classroom may benefit students not classified as having disabilities.

As such, the sum of General Education and Special Education Instructional Expenditures does not equal the Total Expenditures.

## **AP Economics**

With Cal-Mum High School AP Economics students preparing for college and entering the workforce in the next five years, the future of the U.S. economy looks robust.

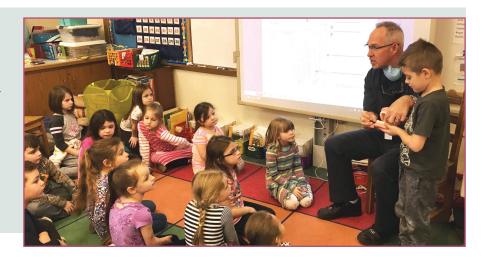
## Red Raider Family Runs Deep

#### **Absentee Ballots**

Qualified voters who are unable to vote in person on Tuesday, May 21, 2019 due to illness, travel, or others reasons specified by law, may use an absentee ballot. ### State Regulations Regarding the Budget

State regulations require that school districts inform the public of the options available to the Board of Education in the event that a budget is not passed. A Board of Education has several options:

- 1. Resubmit the original budget for another
- 2. Submit a revised budget for voter
- 3. Adopt a contingent budget at a 0% tax levy increase

Under the educational law regarding a contingent budget, the spending increase cannot exceed the total amount of spending in the prior year budget. A contingent budget requires that the Board of Education charge for community use of school facilities and grounds for non-school activities.
