

Dear Caledonia-Mumford Parents and Residents:

First of all, I hope you and your family are well. Secondly, you will notice that this budget newsletter is different from past years due to circumstances out of our control. Please visit our website for more detailed information regarding the proposed budget and its development.

On Tuesday, May 12, 2020, the Caledonia-Mumford Board of Education unanimously adopted the proposed 2020-2021 School Budget of \$18,796,774. On June 9, 2020, district residents will cast an absentee ballot on the proposed 2020-2021 school budget (see information below). The proposed budget represents a 1.94% percent spending increase from the current year. The proposed budget calls for a 1.99% tax levy increase and for the ninth year in a row, the proposed tax levy is below the State allowable limit. In addition to the school budget, residents will also elect two candidates for the Board of Education and vote on the purchase of one school bus.

Unfortunately, the New York State Government did not provide any additional state aid to school districts for the 2020-21 school year. In fact, the State government cut education funding by 1.1 billion dollars by applying a Pandemic Aid Adjustment (a deduction). The deduction of aid resulted in Caledonia-Mumford losing \$140,605 of stimulus CARES money, which was allocated from the federal government. Furthermore, Governor Cuomo has the authority to cut aid throughout the school year if revenues fall short of expenditures. Therefore, it is inevitable that adjustments will be made during the 2020-21 school year unless the federal government provides relief.

Due to no new funding, the district reduced its proposed expenses totaling more than \$600,000 to balance the recommended budget and keep the tax levy increase below the State mandated tax cap. The reductions are identified in each budget presentation that can be viewed on our website.

Board President John Bickford said, "From the onset of the development of the 2020-21 school budget, it was our focus to provide quality educational opportunities for our students while being fiscally responsible to the tax payer." The budget that district residents are being asked to consider fulfills the District's mission and stays within the property tax cap. The Board believes that the proposed school budget maintains an educational program that will continue to be a source of pride for the community.

Vice President Arnold Rychlicki said, "This year's budget development was much more difficult than in previous years due to frozen State aid and the uncertainties of potential mid-year State aid cuts. The budget being presented to residents supports a high quality, well rounded educational program for our students."

The proposed 2020-2021 school budget will:

• Provide support to maintain its core Pre-K-12 academic programs.

- Provide funding for Advanced Placement courses in Math, English, Social Studies, Science, Art, and Psychology. In addition, college level courses at Genesee Community College (GCC) and Rochester Institute of Technology (RIT) will continue.
- Preserve all art, music, co-curricular activities and the athletic program.
- Provide funding for a full-time School Resource Officer.
- Provide funding to implement year three of the District's Strategic Plan Initiatives.
- Adhere to the State imposed tax levy cap.
- Preserve the full-time English as a New Language teacher position.
- Maintain small class sizes.
- Include resources to support the Olweus Bullying Prevention Program and resources.
- Include additional funding for instructional materials for ELA, science and social studies curriculum.
- Include funding to implement five senior high electives AP Computer Science, Modern Drama, Performance Physical Education, War and Conflict and Law and Justice.
- Continue the district's commitment to the implementation of a multi-year Technology Plan.
- Appropriate funding to provide high-quality transportation services for district resident children.

- Include funding to develop a long-term instructional and financial strategic plan.
- Provides funding to replace the elementary loading dock and sidewalk that connects the elementary and middle schools.
- This budget protects the community's investment in facilities, infrastructure and programming.
- Provides funding for summer school reading intervention program for grades 4-8.
- Provide funding to support increased professional development opportunities for staff.
- Meet legal mandates and contractual obligations.

In addition to the proposed school budget (Proposition #1), voters will be asked to vote on Proposition #2, which seeks your approval to purchase one bus 64 passenger bus not to exceed \$130,000. The bus will be financed over five years to coincide with the district's receipt of Transportation Aid.

In accordance with Governor Andrew Cuomo's Executive Order No. 202.26, our annual budget hearing will be held via videoconference. We invite you to attend the virtual annual Caledonia-Mumford Central School District Budget Hearing on Tuesday, June 2, 2020, at 7 p.m. The videoconference will be open to the public; more details and a link to the videoconference will be available on our school website and our social medias (Facebook and Twitter).

I value education and the opportunities it brings students. I encourage and value transparency as well as honest and candid discussions within our board to best meet student, district and community needs.


I continue to have great respect for all staff in the CMCS school district and it would be an honor to serve our community and district for another term.




Proposed 2020-2021 Three Part Budget Summary

Annual Budget Referendum 2020-2021

Proposition #1

BUDGET RESOLUTION

BE IT RESOLVED, that the proposed budget of expenditures for the fiscal year 2020-2021 in the amount of \$18,796,774, and for the purposes shown in the statement of estimated expenditures adopted by the Board of Education, be one and the same, hereby is approved and the amount thereof shall be raised by a levy of a tax upon the taxable property of the school district.

Proposition #2

BUS RESOLUTION

RESOLVED, that the Board of Education of the Caledonia-Mumford Central School District is hereby authorized to undertake the acquisition of one (1) 64-passenger school bus at an estimated maximum cost of \$130,000, less trade-in value, if any, and that such costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments; and, in anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$130,000 shall be issued, or the school district may enter into an installment purchase contract if the Board of Education determines that it is in the best interest of the school district to finance the purchase in that method.

Proposition #3

FOR MEMBERS OF THE BOARD OF EDUCATION - VOTE FOR ANY TWO (2)

Two district residents have submitted petitions to run for two seats on the Board of Education. Each open seat is for a three-year term beginning July 1, 2020 and expiring on June 30, 2023.



Qualified voters are persons that are United States citizen, eighteen years of age or older and a legal resident of the school district for at least 30 days prior to the date of the vote.

In the event the proposed budget is defeated and a contingency budget is adopted, the District would be prohibited from purchasing equipment, certain supplies, as well as any costs associated with the community use of school facilities.

STATE REGULATIONS REGARDING THE BUDGET:

State regulations require that school districts inform the public of the options available to the Board of Education in the event that a budget is not passed. A Board of Education has several options: • Resubmit the original budget for another vote • Submit a revised budget for voter approval • Adopt a contingent budget at a 0% tax levy increase

Under the educational law regarding a contingent budget, the spending increase cannot exceed the total amount of spending in the prior year budget. A contingent budget requires that the Board of Education charge for community use of school facilities and grounds for non-school activities.

Estimated Tax Information

Homeowners are eligible for tax relief under New York State's School Tax Relief Program (STAR). Upon application, homeowners may be eligible for up to a \$30,000 decrease in their assessment. Senior citizens (age 65 and older) may be eligible for Enhanced STAR for up to a \$69,800 decrease in their assessment.
