PROPERTY & SUPPLIES / USE OF FACILITIES

1. ***(Property & Supplies/ Use of Facilities)*** Recommend approval for New Oxford Beginning Champions Wrestling Club with Brian Tomecek as representative, to use the New Oxford High School gymnasium, wrestling room, and cafeteria on January 7, 2023, from 9:00 am to 2:00 pm for a League Wrestling March, with charges as listed in Board Policy #707, with the provision of proof of insurance as per Board Policy and for the services of custodians, security, cooks, and/or technical personnel as needed.
