Credential Information

California Statewide Assignment Accountability System Reports Now Available for 2022-23 School Year

The California Commission on Teacher Credentialing (CTC) has finalized the data in the California Statewide Assignment Accountability System (CalSAAS) for the 2022-23 monitoring cycle. Reports are now available for users to access. Some predetermined



exceptions were excluded from the user interface during monitoring in order to boost system performance and are included in the final reports. These exceptions can be found in the Hidden Predetermined Exceptions Report.

We highly recommend that you download your reports and save them for your records. For more information and guidance, see [CalSAAS reports](#).

Note: Education Code 44258.9 requires misassignments be corrected within 30 calendar days. Please see additional information on reports and exception types on the resource listed above.

2022-23 CalSAAS Assignment Monitoring Results

There were 7,578 total exceptions in San Diego County public schools, including charter schools.

- 1,012 Misassigned
- 1,8911 Local Assignment Option (Ed Code Option)
- 450 Vacancies
- 1,822 CalPADS Errors
- 21 for 2019-20 Charter Flexibility
- 10 Temporary Permits for Statutory Leave

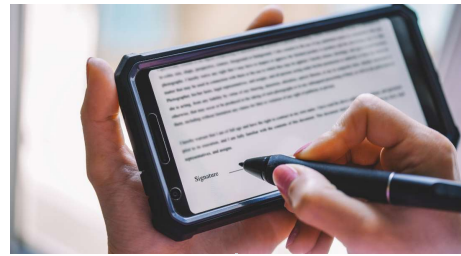

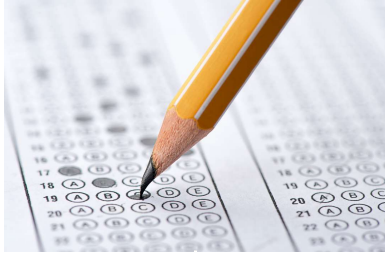

CALPADS Regional Update Meetings

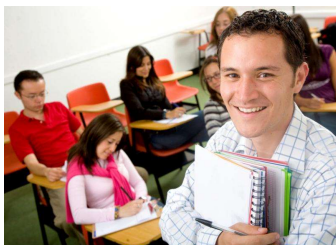
