<u>Presentations</u> - Book Tour (Nancy Waldeck's 4<sup>th</sup> Grade Class) - Nancy Waldeck's students read the book they published, *Run, Norma Run!*, to the Board which was based on a true story of a cow that was loose in the Utica area for several months. **MS4 Annual Report (Steve Parker)** - Steve Parker, Director of Facilities III, gave his annual report to the Board on storm water management. This is a program the state started back in 2011. The report is available on the districts web site. **Spring Sports Report (Doug Jones)** - Doug Jones, Athletic Director, complimented Steve Parker and his crew on how great the grounds look. He then reviewed the highlights of each spring sports team accomplishments.
