The meeting was called to order at 7:02 p.m. by Mr. Nicotera.

<u>Pledge of Allegiance</u> - The pledge of allegiance was recited.

Presentations - 8th Grade Multi-Day Educational Field Trip (Melissa Leone and Kathie Dudek) - Mrs. Leone, ELA teacher, and Mrs. Dudek, teacher assistant, provided the Board with information regarding the Disney Leadership Institute. This is an opportunity they would like to open up to 8th grade students via an application process. Pending Board approval, the program would be held from May 3-7 (Friday-Tuesday), 2019 at Walt Disney World, Florida. The total cost for each student would be \$1,087. Mrs. Leone and Mrs. Dudek are seeking ways through grants, community foundations, etc. to offset the cost. - that the quarterly extra-classroom activity report be approved as presented.
