Presentations -

- 1. Music Awards (Mr. Decker, Henryk Lotyczeski, & Stephanie Paine) Mr. Decker, Music Director, announced each 52 students individually who received music awards at the New York State School Music Association (NYSSMA), Elementary All County (EAC), and Junior High All-County (JHAC) as the other music teachers presented the certificates to the students. One student, qualifies to go to the state in September due to his high scoring and performance.
- 2. Disney Leadership Trip (Mrs. Hajdasz, Mrs. Dudek, & Mrs. Leone) A group of 11 8th Grade students went to Florida with the financial assistance from the Foundation and local funding.
