Mr. Wheelock stated that at this point everything in place is working with only minimal outbreak of COVID and until the social distancing guidelines are lessened we won't see a shift in our instructional model. We will look into this later in the school year should the guidance permit us.

Mr. Nelson asked about the Center State Conference in regards to winter sports. Are the coaches appointed for the winter sporting events and will they be able to play? Mr. Wheelock stated that there is a meeting scheduled for league President's with Section III and as the chair of the Chief School Officers Committee in the Section, he plans on attending. Mr. Nelson stated that the low to moderate sports included bowling, indoor track, skiing and swimming.

Mr. Nelson's second question was Sauquoit Valley District's financial status. Is it possible to schedule another audit? Mr. Wheelock agreed that this is a great idea and one will be scheduled. This will be one of many including public forums, so when it comes time for the school vote the public will be informed.

Motion 9.2 was passed and Mr. Nicotera just asked if it is the salary that is causing the turnovers. Mr. Nelson suggested to approach local colleges at their Career Days. Ms. Brennan- Vuocolo commented on that MVCC has one and she thinks it may be a virtual one this year and agrees that it is a good idea. There was none in the chat room.
