Pledge of Allegiance – The pledge of allegiance was recited.

Presentation -

- 1. **Finance** Mr. Wheelock summarized the financial meeting that was held prior to this one. The financial status of the school is not good. The governor of the state has held 20% of the 2019/20 school funding and is planning on doing the same with 2020/21 school year funding which will leave the school in fiscal distress. Spending is frozen with exception to essential items and other avenues may need to be addressed to mitigate our funding deficit. The District used its reserve money to fund a portion of this year's budget and this money will not be available for the 2021-22 school year. We have amassed nearly \$60,000 for unexpected expenditures due to COVID-19. Board members have agreed to make 3 year plan with different scenarios to address our financial crisis.
- 2. Athletics The Board was asked if they supported allowing fall athletics to take place at this time. Mr. Wheelock shared a number of concerns to be aware should we consider sports at this time. Concerns such as: a disconnect between the safety protocols during the school days for physical education, band and choir versus a more relaxed protocol for athletics; screening guidance during the school day is more stringent than what is required for athletics; we are adding another layer of exposure to our staff and students by introducing athletics at this time which could jeopardize the work that went into preparing for the reopening of school; additional strain on our cleaning staff to have to frequently clean and disinfect areas associated

with athletic use; more stringent protocols on mask wearing during the school day versus after school for athletics. Last May the District adopted a budget with some proposed program cuts (athletics, extra-curricular activities) but included them in the budget with the hopes that more Federal aid would be coming to the states. As of the date of this meeting, there has been no further federal monies forwarded to the states and New York state is withholding 20% of state aid from our last state aid payments in 2019-20 and threatening to withhold 20% of state aid into the 2020-21 school year. Mr. Wheelock shared that we need to consider the state of our finances when considering to go forward with athletics at this time as well. Many feel that students need that extra socialization and social-emotional activity. The social distance factor would be eliminated in many sports. There are different regulations coming forward and the language; "considered" or "should" leaves interpretation wide open to what is really required. Fall sports being an outdoor event makes it less contagious to others in the building. Board members like to still hold fall sports. The board members agreed to leave the decision as to which sports and at what levels to participate to the athletic director and administration.

Public to be Heard (comments from chat room) – Public had positive comments on keeping the athletic department running and would like to know as soon as a decision is made as to which sport will occur. Doug Jones, Athletic Director stated that a decision will be formulated sometime Thursday and Mr. Wheelock will send out a robo call.

Students to be Heard – There was none in the chat room.

Board of Education Sub-Committee Reports – There was none as Mr. Wheelock had already spoke above on the financial status.

Superintendent's Report

Mr. Wheelock read the open enrollment of students as of September 9, 2020.

He also informed every one of the free lunches to all 18 year old and younger students through December 2020.

The information for the SBI Membership Meetings are held in person and zoom. The schedule was sent out prior to tonight's meeting.
