Public to Be Heard:

- Lisa Murphy was concerned about the behavior at Waterville during the boys' soccer game. She was scared for the players, herself and everyone there from Sauquoit.
- Linda Jones was upset as well with the threat that was present at the game. It wasn't just the players. Parents were also involved in making the situation unsettling.
- Rebecca Barker spoke of the same uncomfortable scary feeling for the safety of the Sauquoit soccer players, herself and families. The parents formed a barrier line so their children/players could board the bus without getting harmed. The language and verbal abuse was uncontrollable.
- Sarah Hinman also spoke of the insecurity and stress she and her family felt at the
 Waterville soccer game. She would like the board to have security present at games
 against Waterville or have Waterville soccer team forfeit future soccer games due to
 their misuse of the code of conduct. Having an officer present to enforce safety at all
 games would be good.

Miscellaneous Topics: Mr. Nicotera commended the Sauquoit parents for not engaging with the Waterville parents at the end of the boys' soccer game in Waterville on October 6th. The other board members present thanked the parents for coming forth and expressing their concern. They do understand how you feel as they have students here as well and do not want them to fear attending or participating in an extra-curricular activity of the school. Mr.

Wheelock then spoke and agreed with the safety concerns expressed, shared his concerns for increasing negative fan behavior at sporting events, and that the Board needs to consider the request for having law enforcement present at all sporting events at Sauquoit Valley for the safety of everyone.
