Public to Be Heard: Three requests were made.

1. Chris Roberts wanted to inform others of his lawsuit that he has filed against the district and certain individuals in the District, regarding COVID related procedures and protocols that were put in place last year. He feels that they should not have been in place. Studies are showing many that received the vaccinations are now having strokes. He also stated that schools should not change terminology on gender. Children are young and this may confuse them. He heard that distancing in schools is still occurring and wonders why?

Mrs. Miller called Peter Bianco to speak. He was not present.

- 2. Michelle Babbie introduced herself as the high school librarian, senior class advisor and president of the teachers' union. She also took the time to thank the board for the new furniture purchased in the library and that the staff and students love it.
- 3. Peter Bianco arrived and Mrs. Miller called upon him to speak. Mr. Bianco discussed similar outcomes to the vaccinations and the number of deaths associated with the vaccine that Chris Roberts spoke of. He feels that there is harm in receiving the vaccine and no test results have proven what it is doing to children. Other vaccines for diseases have been pulled such as polio as it is believed have caused some people to die from it. So, why

promote COVID vaccines if people are dying from it? The vaccine is not fully approved. It was offered only for emergency use. He further feels that schools should not be promoting the vaccine.

He also commented on the Town of Paris assisting in making the district look good.
