Presentation(s) - There were none.

Public to Be Heard – There were none.

Sub-Committee Reports – Last Tuesday there were about 30 people who joined the School Boards Institute (SBI) zoom meeting with the Assembly representatives in this area. The assembly persons are committed to phasing in Foundation Aid for those schools who have been underfunded. Sauquoit Valley has not been underfunded in the State's eye and will received to minimum 3% increase in Foundation Aid for next year. The canceled Senators meeting is rescheduled to February 10th, 2022 at 6 p.m. This is a zoom meeting which the board members have received an email prior to this meeting with the link to join.

New Business - Mrs. Miller stated that action 9.1 is voided and items 9.2 to 9.10 will be read as a consent motion and take one vote. - to appoint Alyssa Orsino, to the position of teacher in the elementary tenure area, for probationary period of four (4) years to commence March 7, 2022, unless able to start sooner, and to expire March 7, 2026 (This expiration date is tentative and conditional only. Except to the extent required by the applicable provisions of Section 3012 of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least three (3) of the four (4) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time).
- that the quarterly extra-classroom activity report be approved as presented.
- BE IT RESOLVED, upon the recommendation of the Superintendent of Schools, that the Board of Education accept a donation from the Ed Wadas Foundation in the amount of \$14,895.09 for the purpose of purchasing an indoor batting cage and that the Board also authorizes a budget modification to increase account code A2855.200-00 in the amount of \$14,895.09 to allow for the purchase of the batting cage.
- that the minutes of the January 18, 2022 meeting be approved.
- that authorization be given regarding the payment of bills approved by the claims auditor (dated Jan. 24, 2022).
- that the Board of Education upon completion of its review of the IEP in accordance with Section 200.4(d)(2) of the Regulations of the Commissioner agrees to arrange for appropriate special education programs and services for students numbered 1401456, 1401427, 1401043, 1401073, and 1401452 as recommended by the Committee on Special Education.

Improvements to our undesignated fund balance has help and will continue to better assist our financial position.
