<u>Enrollment Fee (community)</u>. Payment of the community SAS enrollment fee is an acceptance of Bellevue Christian School's offer to enroll in the SAS program and is confirmation the enrolled student will participate in community SAS sessions. It is due upon enrollment and **non-refundable** once billed or paid, no matter when the student is enrolled. The enrollment fee is not a deposit on, nor a prepayment of, tuition.

<u>Annual Tuition</u>. Bellevue Christian charges annual tuition due May 1. Payment plans are offered as an alternative to making payment in full. All payment plans are governed by BCS tuition payment and withdrawal policy, outlined below, and the enrollment contract.

- One-Pay A: paid in full by May 1, 2024, with a 2% discount. Option to pay by BCS-managed ACH with prior arrangement, bank bill payment, or through Veracross portal (VC Pay). Discount expires May 2. VC Pay convenience fees apply.
- One-Pay B: paid in full by May 1, 2024, by wire or Flywire (this option is for payers with international funds). Does not receive 2% discount.
- Ten-Pay: paid in 10 monthly installments beginning May 1, 2024, and ending February 1, 2025, by BCS-managed ACH, bank bill payment, or VC Pay. Does not receive 2% discount. VC Pay convenience fees apply.

Payment Terms

- Payments are due by the 1st of the month; payments via ACH will occur on the 5th of the month.
- Account balances that are paid by the 5th of the month will avoid late fees.
- All unpaid accounts will be subject to monthly late fees totaling \$65.
- Any payment that is returned for any reason will be subject to a \$25 return fee (check/bank bill payment/ACH) or \$15 return fee (VC Pay).
- Bank and card payments made through VC Pay will be subject to convenience fee.
- Students may not participate in the SAS program beginning the first day of the following month if the previous month's balance is not paid.
- Missed sessions are not reimbursed.

SAS Program Commitment. Parents/guardians will agree and affirm during online enrollment or reenrollment:

- Affirm understanding that the Educational Therapy is not a quick solution to the learning difficulty of the student.
- Affirm understanding of the program's goal for the student and belief in its basic philosophy.
- Agree that continuing with SAS Educational Therapy participation is a commitment to the education of the student.
- Agree that if participation in SAS Educational Therapy is a condition of the student's enrollment at Bellevue Christian School, the student must remain enrolled in the SAS program in order to be an enrolled student at the school. (If in doubt whether your student's SAS enrollment is a condition of school enrollment, contact the SAS director to confirm.)
- Affirm understanding that for the student to reach the goals described in the therapy program it may take a minimum of two to three years or more, depending on the learning needs of the student.
- Affirm understanding that the student will receive SAS testing at the end of the school year and that the student's therapist and/or the SAS
 director will communicate the test results to parent/guardian, at which time an updated academic plan will be determined for the following school
 year.
- I/we understand and agree that responsibility to pay tuition is not based on my/our student's academic success.

<u>Separation from School; Payment Policy</u>. Family will have at least 80% of annual SAS tuition responsibility. BCS makes employment commitments to therapists and orders supplies based on the student's participation in this program. Unless modified or cancelled in writing by the SAS office after end-of-year or end-of-semester testing, <u>parents/guardians agree to tuition responsibility of at least 80% of annual tuition based on the student's calculated number of sessions</u>. Tuition responsibility is as follows:

Any time February 1, 2025, to end of school year	Enrollment Fee. Tuition responsibility is for all 5 months of the 2nd semester; no proration of month.	

Standards of Conduct and Tuition Responsibility. Student and parents or guardians will be required to affirm understanding of and agreement with the parent/student handbook in its current version as found on the BCS website. If student leaves or is asked to leave BCS or the SAS program for reasons including but not limited to behavioral, academic, or social, or due to the conduct of the parent or guardian, or due to non-payment of tuition for whatever reason, parent/guardian will remain responsible for the SAS tuition subject to the above withdrawal policy. (Official transcripts and student records are provided only when tuition responsibility is paid.)
