DAC Presentation:

Curt Wilson reported that training is underway. The 3rd Grade reading will be done the last week of February. TCAP tests should be arriving onsite this week and testing will probably be complete before Spring Break the last week of March.

ADMINISTRATION REPORT

Mr. Schott reported on the following: Parent Teacher Conferences went well; there are 10 wrestlers that qualified and will going to State Feb 20-22 at the Pepsi Center in Denver; Next year looking at scheduling PTC on the week of State Wrestling so the Friday we are already scheduled off; Plaques for "Teacher Recognition" being done by the Wood Shop; "Day at the Capitol" – Mark Bahr, Kevin Schott, Susan Hamilton, Natalie Taylor and John Camponeschi attended. They talked about bills, issues from the Education Committee, shared concerns with Senator Johnston, Senator Todd and Larry Crowder, became aware that even schools like Cherry Creek face the same problems we do with getting technology and SB191; Gifted and Talented group visiting Capitol Hill this week; Discussion on PD360, a program to help Administration evaluate and provide professional development, cost is \$28,000, we will pay half the cost from this year's budget and the remaining out of next year's budget; the program has a 12 month contract. For the district's 1338 Committee – we will use our District Accountability Committee. The 1338 committee looks at other parts of the evaluations in SB191. Feb 20 and 21 is CASB Legislative Session, Mark Bahr and Mr. Schott will be attending.

Mr. Chavez moved that the Audit Presentation be moved up to this point in the meeting.

AUDIT PRESENTATION

Cassandra Martinez of Martinez & Associates, Inc. gave the Audit Report for July 1, 2012 to June 30, 2013 fiscal year for the North Conejos School District. Ms. Martinez reported it was a clean audit. Good job with two year comparison. Federal Funds – Suggestion of amending the budget by June 30 year end when awards are known to avoid violation of State Statue. Budgeting was the problem with violations in State Funding portion. Bottom line in General Fund is what needs to be focused on. No problems here. Capital Reserves were spent on Technology, water line and baseball field. Food Service – paying for adult meals was a big change and there was also an increase in Food Service Salaries. Food Costs have gone up significantly, which affects the finances. Ms. Martinez noticed that a violation was missed in this part of the report and would amend the report with the violation added.

Management Recommendation -

- *Everything went well with the audit.
- *Food Service needs to look at what the cost of a meal should be per plate. Not sure we are charging enough.
- *Finance Manager needs to be more involved with Food Services finances.

Report is due to state February 28, 2014 by auditor.
