BOCES Report

Joseph Baroz reported that the next BOCES meeting will be tomorrow, November 14th and Brandon Thomas will be attending.

NCEA Report:

Bonnie Keller reported that Amendment 73 didn't pass. We need to educate the public more on this issue. She asked the board and staff to promote the new high school and to use their voice to promote this.

Administration Report:

Promising Practices with the Colorado Department of Education will be here to highlight North Conejos School District on November 28th. They highlight schools and districts in the state of Colorado and the film crew will be here to interview 5-6 people and film classrooms.

It may be more difficult in the future to recruit bus drivers as there are many new credentials coming that may make it a challenge for transportation.

There was staff training on November 2nd to promote anti-suicide efforts and to educate our staff.

CHS students will be going in to the elementary and middle schools to promote anti-drugs/opoids. Our older students have a real influence on our young students and past experience has shown this to be a valuable tool.

Mr. Wilson feels the need to have better relationships with families and special needs students. He would once again like to have older students mentor the younger students in this area.

CHS football will be hosting a state football playoff game this Saturday, November 10th.

Mr. Wilson will meet with Leroy Martinez tomorrow on potential land plans for a new high school.

Mr. Wilson shared a quote with the board and those in attendance, "if you want excellence – you must have better efforts".

DISCUSSION ITEMS

BEST Grant – DPS Architects

Mr. Wilson and Board members held a conference call with DPS Architect representative Dan Kemmee. He had a power point sharing updates on CHS programming: (1) schedule and scope – steps to apply to CDE for a BEST grant (2) taking feedback to come up with "floor plans" and cost estimates (3) apply to CDE in January-February (4) if approved funding to come next summer (5) project goals include a new identity, enhance school reputation for high achievement, single identity and department groupings, air quality, fewer entries, inviting, natural light, views, study area, bus drop off (6) building analysis summary – do we renovate or build new? We need to show the state that it is better to build new than renovate CHS (7) program of spaces – we must meet state requirements when making decisions on school wants. Standards are a starting point but any space needs to be justified by the school and community needs (8) Scheme C & E seemed to be favored in the community presentation by DPS (9) Our next steps: a) modifications b) revise site design with feedback c) begin building design d) present to the board and community e) prepare cost estimate f) BEST grant application

Mr. Wilson handed board members updates on BEST and mill levy information

Request to Reconsider DPS Decision

North Conejos School District RE-1J received accreditation results from CDE and the District has earned Accredited with Distinction which is 3 years in a row for NCSD. This a great feat and Mr. Wilson applauds students and staff for the excellent efforts.

Absence/Truancy Protocol

Mr. Wilson is trying to put something in place before we go to court with students and families. We need to watch attendance and truancy closely with the 4 day week. Our data shows the majority of problem absences come from split home families.
