# **REQUEST FOR PROPOSAL**

#### **Description of Project:**

The Da Vinci Science Center and the Allentown School District (ASD) have joined forces in an innovative museum-school partnership that provides ASD students with state-of-the-art immersive learning experiences in Science, Technology, Reading, Engineering, Art, and Mathematics, or STREAM, at the Science Center's new facility in downtown Allentown and expands ASD capacity for next generation science, teaching, and learning.

As a result, the Allentown School District is seeking support in the development and implementation of STREAM curriculum, assessment, and learning experiences.

#### Allentown School District

Allentown School District ("ASD") is inviting proposals from qualified companies for curriculum, assessment, and learning experiences for a new STREAM Academy, scheduled to open in Fall 2024.

# INTRODUCTION


#### **Statement of Work:**

Allentown School District ("ASD") is seeking proposals from companies who will provide high quality support in developing and implementing curriculum, assessment, and learning experiences for students and teachers to launch a Science, Technology, Reading, Engineering, Arts, and Math (STREAM) Academy in partnership with Central Elementary School and Da Vinci Science Center ("DSC"). DSC is building a new Science Center 3 blocks from ASD's Central Elementary School. This new site will serve as a second campus for Central Elementary with daily access to Da Vinci's STEAM Learning Center, exhibit galleries, Fab Lab and Media Production Studio. The priority of this project is developing experiences for Grades PreK through 5<sup>th</sup> first, with the potential to provide experiences for Grades 6-8 in the future. The suggested scope of work for services is listed below. Components may be modified through negotiation and/or by written addendum issued by the District and will be made a part of the Agreement.

#### **Demographics:**

The Allentown School District is a large, urban public school district located in Allentown, Pennsylvania, in the Lehigh Valley region of eastern Pennsylvania. The District is the fifth-largest school district in Pennsylvania. The Allentown School District has 24 schools comprised of three high schools, four middle schools, fourteen elementary schools, and three specialized options.

Allentown School District (ASD) serves approximately 16,100 students in Kindergarten through Grade 12. ASD serves approximately 1275 students per grade level in Kindergarten through Grade 5 for a total of 7650 students across 14 buildings and an Elementary Newcomer Academy. There are approximately 450 teachers in Kindergarten through Grade 5 including regular education, special education, ELL, and reading specialists/interventionists. ASD serves approximately 1200 students per grade level in Grade 6 through Grade 8 for a total of 3600 students across 5 buildings and a Newcomer Academy. ASD serves approximately 5200 students in Grade 9 through Grade 12 for a total of 5200 students across 4 buildings and a Newcomer Academy. There are preschool classrooms in 8 of the elementary schools. ASD serves approximately 126 pre-kindergarten students at eight elementary schools. The Allentown School District student population demographics include the following:



#### **District Mission:**

Each and every student will graduate college and career ready by having their individual needs met through active engagement in a rigorous, safe, and nurturing learning environment.

#### **District Vision:**

Each and every student, with the active support of the entire community, will graduate ready to thrive in a diverse and complex world.

#### **District Beliefs:**

- 1. Honoring each student's unique qualities
- 2. Ensuring equity of access and opportunities
- 3. Nurturing the pursuit of lifelong learning
- 4. Strengthening partnerships with families and communities
- 5. Promoting cultural responsiveness

#### **District Theory of Action:**

If we create a shared vision of excellent learning and teaching and provide adequate and differentiated resources including partnerships responsive to the identified needs of students and adults; build our own muscle to monitor for consistent implementation; and model best practices in professional development/capacity building through onsite professional learning and coaching, THEN we will reduce variability in learning outcomes, accelerate progress, and increase academic performance for all students.

# **GENERAL RFP TERMS AND CONDITIONS**

**CHARACTER**. It is recognized that, for the protection of the children, all persons affiliated with and/or employed by the Vendor must be of stable personality and of the highest moral character. Any persons working on school grounds shall obtain the following clearances: Federal Criminal History Record, FBI Clearance Check, PA State Criminal Record Check, and PA Child Abuse History Clearance. The cost to obtain these clearances shall be borne by the Vendor who is awarded the contract. Copies of the clearances shall be given to ASD upon their request.

**COMPLIANCE WITH LAWS**. The proposal shall at all times observe and comply with all laws, ordinances, regulations, and codes of the federal, state, county, and other local government agencies, which may in any manner affect the performance of the contract. The Vendor, as an employer, shall not discriminate against any worker, employee or applicant, or any member of the public, because of race, creed, color, age, sex or national origin, nor otherwise commit an unfair employment practice.

**CONTRACTOR NOT AN AGENT.** Unless otherwise stated in the final Professional Services Agreement, the Vendor shall not be held or deemed in any way to be an agent, employee, or official office of ASD, but rather an independent contractor furnishing professional services to ASD.

**INDEMNIFICATION.** The Vendor shall indemnify, save, and hold ASD and PDE and all of its employees, officers, directors, subcontractors, and agents harmless against any and all claims, demands, suits or other forms of liability that may arise out of, or by reason of, any noncompliance by the Vendor with any agreements, warranties or undertakings contained in or made pursuant to this Agreement.

**TERMINATION**. Failure by the successful Vendor to comply with the terms and conditions of this RFP or to deliver the Services identified in this RFP or the contract at the prices quoted shall void the contract award. In the case of the successful contractor's failure to deliver the Services in accordance with the contract terms and conditions, ASD, after due oral or written notice, may procure such Services from other sources and hold the successful contractor responsible for any resulting additional purchase and administrative costs.

**COLLUSIVE PROPOSALS:** By submitting a Proposal, Proposer certifies that it has not combined, conspired, or agreed to intentionally rig, alter or otherwise manipulate, or cause to be rigged, altered or otherwise manipulated, its Proposal for the purpose of allocating purchases or sales to or among persons, raising or otherwise fixing the prices of the goods or services, or excluding other persons from dealing with ASD. By submitting its Proposal, Proposer certifies that its Proposal is made without collusion or fraud and that it has not offered or received any kickbacks or inducements from any other Proposer, supplier, manufacturer, or related entity in connection with its Proposal.

# **SCOPE OF SERVICES**

The scope of work is separated into three sections. It includes collaborating with Allentown School District (ASD) and Da Vinci Science Center (DSC) leadership to:

- 1. Design a multi-year Professional Learning Plan and implement Professional Learning Activities associated with all program development outlined in this Scope of Services.
- 2. Develop and implement new or modified curriculum, learning experiences, and assessment in the following areas:
  - PA Science, Technology & Engineering, Environmental Literacy, and Sustainability Standards (STEELS) for grades K-8.
  - State-of-the-art, immersive STREAM learning experience using the Fab Lab, Media
     Studio, and unique exhibit experiences at the Da Vinci Science Center for grades K-8.
- 3. Create multi-year Family and Community Engagement Activities associated with all program areas in this Scope of Services.

A separate RFP has been issued for the development of PreK professional development; curriculum, learning experiences, and assessment; and family and community engagement activities.

#### 1. PROFESSIONAL LEARNING ACTIVITIES

- For each section in the scope of services #2, develop and implement ongoing professional learning experiences.
- Support development of a comprehensive multi-year professional learning plan.
- Create professional learning for various ASD and DSC roles such as teachers, intervention specialists, support staff, principals, other leaders and administrators, with targeted learning experiences for each.
- Plan for ongoing, sustained support of professional learning, including for new teachers and administrators.
- Implement selected professional learning activities according to the professional learning plan.
- Select or develop professional learning activities based on evidence.
- Model classroom experiences and use student work in professional learning activities.
- Begin professional learning activities to help teachers learn new curriculum for Fall 2024 no later than Summer 2024.

#### 2. INNOVATIVE STREAM CURRICULUM, ASSESSMENT, and LEARNING EXPERIENCES

- PA STEELS Aligned Curriculum, Assessment, and Learning Experiences for Grades K-8
  - Bring expertise in Next Generation Science Standards (NGSS) to develop, modify, or adapt curriculum, instructional materials, and assessments.
  - Ensure that standards unique to PA STEELS that may not be included in other NGSS aligned curriculum, such as Environmental Literacy and Sustainability, are addressed in the curriculum and learning experiences.

- Utilize the unique resources of the ASD STREAM Academy at Central Elementary and Da Vinci Science Center including exhibits, science shows, classrooms, professional staff, and more to modify or create new learning experiences.
- o Provide instructional materials in multiple languages.
- Center curriculum on engaging phenomena that are relevant to students in ASD.
- Create literacy rich instruction that gets students talking, writing, and thinking like scientists and engineers.
- o Include up to 4 units per year for grades K-8.
- For each unit, include assessments that are scenario based and focused on reasoning aligned with 3-dimensional learning.
- The project will take a phased approach starting with the completion of K–2<sup>nd</sup> grade curriculum, then 3<sup>rd</sup>-5<sup>th</sup> grade, then 6<sup>th</sup>-8<sup>th</sup> grade.
- o Provide instructional materials in English and Spanish. Arabic is also preferred.
- Curriculum for K-2<sup>nd</sup> grade must be completed by opening at the end of August 2024.

### State of the art, immersive STREAM experiences for K-5 using the DSC Fab Lab, Media Studio, and unique exhibit experiences

- Create one project-based learning experience per grade level that aligns with the unique talents and interests of ASD students. Projects for 3 grade levels must be developed by August 2024, with other grades developed every 6 weeks after that.
- Design experiences using the Fab Lab equipment (3D printers, laser and vinyl cutters, t-shirt press, and CNC machine) and Media Production Studio to complement what students are learning in core subjects and introduce cutting edge STEAM concepts and equipment.
- o Provide instructional materials in English and Spanish. Arabic is also preferred.
- Develop assessments to measure student progress and success.

#### 3. FAMILY AND COMMUNITY ENGAGEMENT ACTIVITIES

- For each section in the scope of services #2, develop and implement ongoing family and community engagement experiences.
- Support development of a family and community engagement plan that will connect families and the community with STEAM education being conducted at the STREAM Academy and expose them to STEAM careers.
- Create and implement specific activities aligned with the plan.
- Create activities and communications that are in multiple languages.
- Activities may include but are not limited to social media content, in-person family events, student performances, and more.

# RFP REQUIREMENTS

- 1. All instruction and content used must be consistent with those of the ASD school and Pennsylvania learning standards.
- 2. All services must be aligned with the district's Mission, Vision, and Beliefs.
- 3. All services must be high quality, research-based, and specifically designed to increase academic achievement at all levels.
- 4. All student materials must be in English and Spanish. Arabic is preferred.
- 5. Proposals must describe how the bidder will fulfill the Scope of Services.

#### **DELIVERABLES**

A successful response will include:

- 1. A **letter of transmittal** summarizing the proposal's key points, signed by an authorized officer.
- A proposal narrative that describes the bidder's experience doing similar work in large urban school districts and the methods you would use to accomplish the stated scope of work.
- 3. A **project work plan** including an 18-month timetable that includes key milestones to accomplish the objectives, starting with delivery of K-2<sup>nd</sup> grade materials, then 3<sup>rd</sup>-5<sup>th</sup> grade materials, then 6<sup>th</sup>-8<sup>th</sup> grade materials.\* The work plan should include a proposed combination of in-person and virtual site visits to accomplish project goals. Work will begin in Fall 2023. Teacher training must begin in summer 2024 with the ASD STREAM Academy at Da Vinci Science Center fully operational in late August 2024.
- 4. A **fee proposal** for the services detailed in your work plan. Proposals must include the overall cost of all work, any hourly or daily rates, and cost estimates for travel and time associated with communicating with the ASD staff.
- 5. A **brief biography and resume** for project lead and other project staff, including all relevant work experience.
- 6. Three references.

Proposals should be submitted following the instructions detailed below. The Allentown School District reserves the right to select a proposal in its entirety or some portion(s) thereof. Furthermore, ASD reserves the right to choose portions from multiple vendors if that is determined to be the most advantageous to the school district. The Allentown School District reserves the right to reject any and all proposals and waive irregularities.

Proposals will be selected in October 2023 with work beginning in Fall 2023.

# **EVALUATION CRITERIA AND SCORING**

The School District will evaluate all proposals submitted in response to this RFP through a School District and Science Center Evaluation Committee based on the Proposer's ability to satisfy the requirements of this RFP in a cost-effective and efficient manner. This committee will consider each measure included in the Scope of Services and Requirements, all being weighed equally in scoring, and at their sole discretion, award the work based on this evaluation.

ASD reserves the right to request an interview from those companies determined to be in a competitive range and shall use the information derived from these interviews, if any, in its evaluation.

Evaluation of Proposals will include review of the following:

- 1. Background and experience in working with large urban school districts.
- 2. Background and experience with NGSS and PA STEELS.
- 3. Background with project-based learning.
- 4. Background and experience designing learning experiences utilizing Fab Lab and Media Production Studio equipment and the proposed integration of these learning experiences into the project.
- 5. Background and experience with professional learning in STREAM.
- 6. Creative, innovative, and cutting-edge ideas.
- 7. Ability to create materials in English and Spanish.
- 8. Quality of Family, Student and Community Engagement.

Each item in the Scope of Services and the RFP Requirements will be scored equally using a 1-5 Likert scale.
