

INVITATION TO BID

Notice is hereby given that sealed bids for the work required will be received by the Director of Facilities for the Allentown School District, 1301 Sumner Avenue, City of Allentown, PA 18102 until **9:00 AM, prevailing time, on Thursday, February 22, 2018**, at which time they will be publicly opened and referred to the Board of Directors for final award/approval. Bidders and other interested parties may attend the bid opening which will be held at the time aforementioned.

To provide all materials and labor necessary to perform the work of the project as defined by the Contract Documents and BIA drawing and consists of but is not limited to the following: Full depth pavement restoration at the Muhlenberg Elementary School, mill and overlay at the Trexler Middle School and at the Newcomer Academy.
