Title VII Funding - Impact Aid

Impact Aid is Federal funding provided directly to school districts to make up for lost tax revenues from federally owned property within their boundaries (i.e., military bases and Indian Reservations).

These Title VII funds are managed through the US Department of Education. Impact Aid should not be considered extra funding, but funding that is provided to equalize districts who do not receive tax related revenues like other districts receive.

The Impact Aid law is Title VII of the Elementary and Secondary Education Act, as amended by Every Student Succeeds Act (ESSA).

This information is the basis for payment to your school district of federal funds under the Impact Aid Program (Title VII of the Elementary and Secondary Education Act) and may be provided to the U.S. Department of Education if the school district's application for payment is audited. This form must be signed and dated for the school district to receive funds based on this information.
