and experience in the types of work called for to assure completion of the contract in a satisfactory manner. Any Bidders that is disqualified may respond to the Owner in writing within 20 days of the Notice of Disqualification as to why the Bidders feels that the disqualification is unfounded. The written appeal from the disqualified Bidders will not change the decision already made on this project.
