

1:1 IPAD USER AGREEMENT

The iPad is an exciting learning tool and is intended for educational purposes.

1. 1:1 Device Use and Care

Technology use on and off campus must be in accordance with the mission and philosophy of LSC as well as the acceptable use policy for technology as stated in our Parent/Student Handbook. Teachers may set additional requirements for use in their respective classes. Students agree to:

Please initial next to each item marking that you understand the expectations set forth by LSC:

- Charge the device and bring it to school every day.
- Treat the device with care by keeping it on a flat surface, not dropping it, not getting it wet, not leaving it outdoors, not piling objects on top of it, not leaving it on top of a vehicle, not exposing it to extreme heat or cold, and not using it with food or drink nearby.
- Keep the device in the school-issued protective case at all times. Failure to have it in district-issued case will void the warranty.
- Clean the device with a soft, dry cloth only.
- Return the device when requested and/or upon my withdrawal from Lafayette School Corporation.
- Not lend the device to anyone.
- Not move, rename, edit, delete, or in any way alter the apps, programs, files, or profiles that have been created or organized by LSC. This will result in immediate discussion and action with administration.
- Not write on or place any labels, stickers, or any other decorations on the device or district-issued case.
- Not alter the device in any manner that will permanently change it.
- Not load apps or programs that interfere with educational process or that are inappropriate for a school device. LSC reserves the right to require students to remove apps/software that are inappropriate or interfere with the learning process.
- Practice appropriate digital citizenship.
- Not take pictures or record others without their prior permission.
- Return all issued materials in working condition. If cord or brick is damaged during the year, students will replace the item with an identical product or pay for a replacement (\$20 – charging cable and charging brick combination).

2. Damage or Loss of Equipment

a. Warranty for Equipment Malfunction

LSC has purchased a manufacturer's warranty covering parts and labor. The warranty only covers manufacturer's defects. Families incur no additional charges for repairs covered by warranty.

b. Responsibility for Damage

The student is responsible for maintaining a 100% working device at all times. The student shall use reasonable care to ensure that the device is not damaged. Refer to Section 1 -- 1:1 Device Use and Care for a description of expected care.

c. Accidental Breakage

If an iPad is accidentally broken the parent/guardian is responsible for a deductible payment of \$50.

3. Actions Required in the Event of Loss or Theft

In the event of loss or theft, the student/parent/guardian should immediately report the loss to the individual designated in each building to deal with this event.

a. LSC staff will file a police report if incident occurs *in an LSC facility*.

b. If the device is lost, stolen or vandalized while *not at an LSC facility*, the parent/guardian shall file a police report.

c. The parent/guardian is responsible for the entire cost replacing the device and case if the either is lost or stolen. The parent/guardian will be given the opportunity to purchase insurance.

d. Grade 5/6 iPad/Case - \$370, Grade 3/4 iPad/Case \$271, Grade K1/2 iPad/Case \$299
