MINUTES OF THE MILLVILLE SCHOOL DISTRICT BOARD REORGANIZATIONAL MEETING

MONDAY, DECEMBER 4, 2023

The Millville Area School Board held their reorganizational meeting on Monday, December 4, 2023 in the Millville Jr./Sr. High School Library beginning 7:09 pm. Prior to the meeting, the Board met for an Executive Session to discuss personnel items.






