## TITLE 1 IS...

A federally funded educational program, designed to improve academic outcomes for students. Funding for eligible schools is based on several factors including the percentage of students receiving free or reduced price meals. Provision of academic services is based on academic need. The Title 1 program is designed to help students meet challenging academic standards by providing Title 1 schools with supplemental support and resources.

- Provide additional highly qualified teachers and support staff to provide supplemental instruction
- Purchase additional instructional materials and supplies
- Support parent and family engagement efforts
- Provide professional development

## FAMILIES ARE IMPORTANT

- Work cooperatively with my classmates, teachers and other school staff

### FAMILIES

We/I Will....

- See that our/my child is punctual and attends school regularly
- Communicate with our/my child's teachers on a regular basis
- Support the school in developing positive behaviors
- Provide a home environment that encourages our/my child to learn
- Provide a quiet place for our/my child to do homework
- Stay aware of what our/my child is learning at school
