

SUPPLEMENTAL MEMORANDUM OF AGREEMENT

SUPPLEMENTAL MEMORANDUM OF AGREEMENT BY AND BETWEEN THE SUPERINTENDENT OF SCHOOLS AND BOARD OF EDUCATION OF THE CHAPPAQUA CENTRAL SCHOOL DISTRICT, hereinafter referred to as “the District” and **THE CHAPPAQUA CONGRESS OF TEACHERS**, hereinafter referred to as “the CCT”;

WHEREBY, the District and the CCT believe it to be in their mutual best interests to offer fellowships for extended professional learning experiences.

NOW, THEREFORE, it is agreed as follows:

The following (1) fellowship opportunity will be extended as follows of which the terms of the participation and election are described in the District publication entitled:

Greeley Inc.: Social Emotional Learning Alignment

- a. Extended through the 2020/21 academic year
- b. Up to 20 CCT Member Positions

The stipend will be \$2,500 per year for the 2020/21 school year. This stipend is not subject to any increase for the life of this agreement. This provision will sunset on **June 30, 2021**, unless there is a mutual agreement to extend.

There will be one (1) fellowship opportunity amended to start March 1, 2020 running through February 28, 2022 of which the terms of participation and election are described in the District publication entitled:

Equity, Inclusion and Social Justice

- a. Extended through March 2022
- b. Up to 25 CCT Member Positions

The stipend will be \$2,500 per year for 3/1/20-2/28/21 and 3/1/21-2/28/22. This stipend is not subject to any increase for the life of this agreement. This provision will sunset on **February 28, 2022**, unless there is a mutual agreement to extend.

There will be one (1) fellowship opportunity amended to start February 1, 2021 running through January, 31, 2023 of which the terms of participation and election are described in the District publication entitled:

SHIFT 21: Shaping the Future of Teaching in the 21st Century

- a. Extended through January 2023
- b. Up to 25 CCT Member Positions

The stipend will be \$2,500 per year for 2/1/21-1/31/22 and 2/1/22-1/31/23. This stipend is not subject to any increase for the life of this agreement. This provision will sunset on **January 31, 2023**, unless there is a mutual agreement to extend.

There will be one (1) fellowship opportunity for the 2020/21 academic year of which the terms of the participation and election are described in the District publication entitled:

Wilson Level 1 Certification Program

The stipend will be \$5,000 in the 2020/21 school years. This stipend is not subject to any increase for the life of this agreement. This provision will sunset on **June 30, 2021**, unless there is a mutual agreement to extend.

There will be one (1) fellowship opportunity for the 2020/21 academic year of which the terms of the participation and election are described in the District publication entitled:

Wilson Level 2 Certification Program

The stipend will be \$2,500 in the 2020/21 school years. This stipend is not subject to any increase for the life of this agreement. This provision will sunset on **June 30, 2021**, unless there is a mutual agreement to extend.

The fellowship stipend covers all work associated with the programs and described within the attached publications, with the exception of summer curriculum work which will be paid at the regular curriculum rate. The final decision on fellowship selection will rest solely with the Superintendent of Schools.
