

Current Process

- Current contract expires June 30, 2019
- AAPS issued a Request For Proposal (RFP) on January 31, 2019, due March 5, 2019
- RFP was advertised in Ann Arbor News and posted on BidnetDirect.com/MITN (Michigan Intergovernmental Trade Network). Emails were also sent directly to a list of prospective bidders as required by the Michigan Department of Education
- The required forms required by RFP:
 - Bid Bond (5% of first year value of contract)
 - Pricing Form
 - Notarized Familial Disclosure
 - Exception to Proposal Specifications Form
 - Contractor Information Form
 - Iran Sanctions Act Form
 - Certification Form
 - Completed W-9 Form
 - Certificate of Insurance (General Liability \$1M per occurrence, \$2M Aggregate, Workers Comp. including Employers Liability Coverage \$500K, Automobile and Property \$1M each occurrence)

Current Process

- RFP process for Food Service is under the direction of the Michigan Department of Education
- Prospective bidders were given the current staffing patterns, nutrition standards, sample menus, and financial information about the program
- AAPS received 4 proposals (89 companies received notice and 27 viewed RFP)




