- Ratification of Summer 2021 Purchases. The following summer purchases were presented for ratification:
 - AN-2055: Purchase of outdoor environment equipment for K-8 buildings from Grainger in the amount of \$112,462 funded through the Bond / ESSER grant.
 - AN-2056: Fuel purchase for buses from RKA Petroleum in the amount of \$26,204 funded through the General Fund.
 - AN-2057: Purchase of Air Filter Replacements for all buildings from Midwest Air Filter in the amount of \$130,092 and Air Filter Preventative Maintenance 3-year contract to W.J. O'Neil in the amount of \$75,551 - funded through the General Fund / ESSER grant.
 - AN-2058: Purchase of Math Pilot Textbooks and Teacher Guides for Middle School & High School from Kendall-Hunt Publishing in the amount of \$39,211 funded through the General Fund.
 - AN-2059: Purchase of Math Pilot Textbooks and Teacher Guides for Middle & High School from Open Up Resources in the amount of \$66,880 funded through the General Fund.
 - AN-2060: Purchase of Air Purifiers - Districtwide. Austin Air HealthMate Air Purifiers from Goodyear HVAC Sales in the amount of \$63,550 from Bond / ESSER funding.
 - AN-2061: Purchase of Band Student PPE for music students in grades 4-12 from Francis Enterprises/Stانبury Uniforms in the amount of \$72,354 from General Fund / ESSER grant.
