Emergency Special Meeting
March 29, 2023

The Gallipolis City School District Board of Education met at 4:00 p.m. on March 29, 2023 at Central Office located at 61 State Street, Gallipolis, OH 45631.

Visitor Andrea Snedaker was in attendance.

The meeting was called to order at 4:00 p.m. with President Mr. Morgan Saunders presiding. The following members were present: Ms. Lynn Angell; Ms. Ameer Rees; Mr. Alex Saunders; Mr. Morgan Saunders; Mr. Craig Wright, Superintendent and Ms. Bethany Lewis, Treasurer.

The Board of Education (the "Board") of the Gallipolis City School District, Gallia County, Ohio (the "District") met in emergency session on March 29, 2023, at 4:00 pm, at the Superintendent's Office, 61 State Street, Gallipolis, Ohio, with the following members present:

Ms. Angell Mr. O'Brien Ms. Rees Mr. A. Saunders Mr. M. Saunders

Ms. Lynn Angell introduced the following resolution and moved its passage.

**DECLARING AN EMERGENCY REQUIRING IMMEDIATE ACTION FOR
SELECTION OF DESIGN PROFESSIONAL TO ADDRESS STORM DAMAGE**

The Superintendent recommends that the Gallipolis City School District Board of Education (the "Board") declare an emergency pursuant to R.C. 153.71(B) requiring immediate action with respect to the building envelope at the Gallia Academy Middle School (the "Project") that was damaged by high winds resulting from a severe storm, based on possible health and safety hazards.

Rationale:

- A. Significant damage has been observed on the roof and building envelope of the Project, raising concerns of possible health and safety hazards.
- B. Based upon information provided by Superintendent, the Board believes that an emergency exists with respect to the Project that requires the immediate engagement of a design professional to address and make plans to repair the damage that has been observed with the roof and building envelope of the Project.

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

1. Based on the information provided, the Board finds that an emergency exists requiring immediate action with respect to the damage that has been observed with the roof and building envelope of the Project.
2. Based upon the emergency exception contained in Ohio Revised Code Section 153.71(B), the Board authorizes the Superintendent to engage the appropriate design professionals to address and make plans to repair the damage that has been observed at the roof and building envelope of the Project. The Board authorizes the Treasurer to set aside the appropriate funds for these services.

Ms. Amee Rees seconded the motion and, after discussion, a roll call vote was taken and the results were:
