Due to changes in administrative staff within the district the program has been delayed starting for the school year by approximately 60 days to allow for staff to get settled. Planning is underway for All Pro Dads at the elementary buildings along with Watch Dogs at GAMS with the possibility of expanding to the high school.

Mr. O'Brien asked if the programs have adequate volunteers. Mr. Clark confirmed he has 85 individuals and continues to build.

Curriculum Director Jeremy Hout reviewed the district report card which has moved to a star system. The district received 2.5 stars for the 2022-2023 school year. Director Hout explained each component of the report card and compared the data for each building. He followed with an explanation of the district's next steps for improvement working through the recommendations of the Insight review team along with the district improvement plan which focuses on three areas: OIP process; instruction and assessment; and prevention and intervention.

President Morgan Saunders requested progress updates be provided to the Board. Mr. John O'Brien asked if the staff received the improvement plan well. Director Hout spoke about positives from the last professional development day and support moving forward.


