Pursuant to KRS 158.162, the local board of education shall require the school council or, if none exists, the principal in each school to adopt an emergency plan that must be utilized in case of fire, severe weather, earthquake, or a building lockdown and that: establishes evacuation routes; identifies the best available severe weather zones; develops earthquake protocols for students; and, develops and adheres to practices controlling access to the school building. The emergency plan shall be annually reviewed by the council, principal, and first responders and revised as needed.

In addition to the emergency plan requirements in KRS 158.162, KRS 158.164 requires the local board of education to direct the school council or, if none exists, the principal in each school to establish procedures to perform a building lockdown and to invite local law enforcement to assist in establishing lockdown procedures.

KRS 158.162 also requires the emergency plan be discussed with all school staff prior to the first instructional day of the school year and provided, along with a diagram of the facility, to appropriate first responders. Further, the principal in each school shall conduct, at a minimum, the following emergency response drills within the first 30 instructional days of the school year and again during the month of January: one severe weather drill, one earthquake drill, and one lockdown drill. In addition, required fire drills shall be conducted according to administrative regulations promulgated by the Department of Housing, Buildings and Construction.

1. Has the school council or, where applicable, principal adopted an emergency plan in accordance with local board policy and in compliance with the specifications in KRS 158.162(3) and is a copy maintained on file in the school office?

the entire time while visiting our schools and then return the badge to be shredded at the end of their visit to maintain safety for our building.

2023-24 Phase Two: The Needs Assessment for Schools Understanding Continuous Improvement: The Needs Assessment for Schools

The Needs Assessment Diagnostic will facilitate the use of multiple sources of data to determine the current reality and establish a foundation for decision-making around school goals and strategies. Once completed, the diagnostic will lead to priorities to be addressed in the comprehensive school improvement plan to build staff capacity and increase student achievement. The needs assessment is to be conducted annually as an essential part of the continuous improvement process and precedes the development of strategic goals (i.e. desired state).

While the focus of continuous improvement is student performance, the work must be guided by the aspects of teaching and learning that affect performance. An effective improvement process should address the contributing factors creating the learning environment (inputs) and the performance data (outcomes).

The needs assessment provides the framework for all schools to clearly and honestly identify their most critical areas for improvement that will be addressed later in the planning process through the development of goals, objectives, strategies and activities. 703 KAR 2:225 requires, as part of continuous improvement planning for schools, each school to complete the needs assessment between October 1 and November 1 of each year and include: (1) a description of the data reviewed and the process used to develop the needs assessment; (2) a review of the previous plan and its implementation to inform development of the new plan; and, (3) perception data gathered from the administration of a valid and reliable measure of teaching and learning conditions.

Protocol

The process used for reviewing, analyzing and applying data results included meetings with the school's leadership correlate, our site-based decision making council and through PLC's with grade-level specific teams. At the district level, we meet with our district staff/CIA academic team to review, analyze and make decisions based off of the data presented. Our chief academic officer leads the meets and discusses GAPS and looks for areas for improvement. The meetings are documented through an attendance sheet along with agenda and notes covered for each meeting held.

Review of Previous Plan

2. Summarize the implementation of the goals, objectives, strategies and activities from the previous year's Comprehensive School Improvement Plan (CSIP). What was successful? How does it inform this year's plan?

Perryville Elementary School

Due to the pandemic closures and the GAPS that we saw as a district, the district utilized ESSER funds to create an academic recovery grant that the schools could apply for. This allowed schools to create schedules that focused on math and reading with more minutes built into the schedules for these content areas. This also allowed us to get more resources such as a daytime waiver, after school ESS, more instructional assistants and resources to help build content delivery and close GAPS that we had seen in increase in. This academic recovery grant was successful and our Kentucky State Assessment (KSA) data showed an increase in academics compared to the prior school year. Overall our proficient/distinguish percentages grew from 70% in reading to 78% (8% increase) and math grew from 66% to 81% (15% increase). We were also recognized as a VERY HIGH performing school on the reading/math indicator. We have to utilize the remaining resources since the ESSER grant has continued this school year (with the remaining/limited funds). We analyzed what worked and what areas needed to be strengthened. We have focused on continuing to spend more time in reading and math and utilize one of our teachers as a reading interventionist and the daytime waiver to support the area of math.

Trends

3. Analyzing data trends from the previous two academic years, which academic, cultural and behavioral measures remain significant areas for improvement?

Example of Trends

- The number of behavior referrals increased from 204 in 2021-22 to 288 in 2022-23.
- From 2021 to 2023, the school saw an 11% increase in novice scores in reading among students in the achievement gap.

The number of behavioral referrals have remained steady from 2021-2022. Students in 3rd grade reading saw a 9% increase in proficiency and a 16% in proficiency in math. Students in 5th grade reading saw a 21% increase in proficiency, 27% increase in math proficiency, 20% increase in social studies proficiency, and a 16% increase in combined writing.

Current State

Example of Current Academic State:

- Thirty-four percent (34%) of students in the achievement gap scored proficient on Kentucky Summative Assessment (KSA) in reading.
- Fifty-four percent (54%) of our students scored proficient in math compared to the state

average of 57%.

Example of Non-Academic Current State:

- Teacher attendance rate was 84% for the 2022-23 academic year.
- Survey results and perception data indicated 62% of the school's teachers received adequate professional development.
 - Seventy percent (70%) of students in the achievement gap scored proficient on Kentucky Summative Assessment (KSA) in reading.
 - Seventy-six percent (76%) of our students in the achievement gap scored proficient on Kentucky Summative Assessment (KSA) in math.

Strengths/Leverages

Example: Reading achievement has increased from 37% proficient to its current rate of 58%. The systems of support we implemented for reading can be adapted to address our low performance in math.

- Reading achievement has increased from 70% to 80%. The system of support we utilized through the ESSER grant by allocating more instructional minutes to this area with target focus has helped to address our GAP areas and to increase proficiency school-wide.
- -Math achievement has increase from 66% to 81%. The system of support we utilized through the ESSER grant by allocating more instructional minutes to this
