IPM statement

It is the goal of the Southern Kern Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

Our first objective is sustainable pest control. We seek to control pests in a way that is effective, efficient, and environmentally friendly. Our second objective is to get away from using pesticides, if possible. We want to switch to manual trapping, sticky traps, and gopher traps.

- Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

Pest identification, monitoring and inspection

Pest Identification is done by: Abate A Weed and Kreutel Bugslugger

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by SKUSD Maintenance and Food Services Staff and results are communicated to the IPM Coordinator.

The custodial, food services, and maintenance staff monitor and inspect for pests. This is done weekly in the kitchens, cafeterias, water valve locations, and utility rooms. We use sticky traps for vermin and insects.

Chemical pest management practices

Submittal of pesticide use reports

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt¹ from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm. (Education Code Section 16711)

(Education Code Section 17610.5)
