1. NOTICE TO CONTRACTORS CALLING FOR BIDS

- a. DELETE** Point 17 in its entirety and **REPLACE** with below "Point 17" , Bid Addendum 01 dated February 04, 2022:

"To bid on or perform the work stated in this Notice, CONTRACTOR must possess a valid and active contractor's license of the following classification(s) **B**. No CONTRACTOR or subcontractor shall be qualified to bid on, be listed in a bid proposal, subject to the requirements of § 4104 of the Public Contract Code, for a public works project (submitted on or after March 1, 2015) unless currently registered with the Department of Industrial Relations (DIR) and qualified to perform public work pursuant to Labor Code § 1725.5. No CONTRACTOR or subcontractor may be awarded a contract for public work on a public works project (awarded after April 1, 2015) unless registered with the DIR DIR's web registration portal is: [www.dir.ca.gov/Public- Works/Contractors.html](http://www.dir.ca.gov/Public-Works/Contractors.html)."

2. INSTRUCTION TO BIDDERS
