Northview Elementary is located in Mount Sterling, Kentucky; it is one of four elementary schools in Montgomery County. Northview Elementary is a Preschool through Fifth Grade school. Northview Elementary student population is currently 556 enrolled students. Minority students comprise 5.9% of student enrollment, 8 students are English Language Learners, with 145 students who receive special education services. Our currently eligibility for free/reduced lunch percentage is 60.79%.

As we prioritize learning every moment for our Northview Elementary student community, we embrace a continuous improvement model that is always reflective in instructional practices and delivery. Our SBDM council will review the data provided to each MTSS meeting as well as our bi-monthly topics of PLC agendas.
