1. CALL TO ORDER

Ms. Garcia called the Los Lunas Schools Board of Education meeting to order at 6:00 pm and welcomed those who were participating in the board meeting in person and those who were watching the board meeting via livestream on YouTube. She asked that anyone addressing the Board to use the microphone at the podium and to be sure to identify themselves for the record. In the event there was a disruption in the audio portion, she would pause the meeting until it was reestablished. Ms. Garcia announced that Board Member Smith was out of the country and would not be in attendance, and Mr. Giron would be participating by telephone. She ensured that he could hear and be heard. Ms. Garcia stated Superintendent Kettler was unable to attend the meeting, and welcomed Chief Student Services Officer, Susan Chavez, who be would be filling in for him.

2. ANNOUNCEMENT OF MEETING

Ms. Garcia asked Ms. Chavez to announce the meeting. Ms. Chavez reported the meeting had been announced in accordance with the LLS Open Meetings Resolution, and was a legally constituted meeting of the Los Lunas Schools Board of Education.

8. SUPERINTENDENT'S REPORT

A. Student Representative Report: Aliyah Romero, Valencia High School

Ms. Chavez introduced the student representative for the evening, Aliyah Romero, a senior at Valencia High School. She said that Aliyah lived with her grandmother Karen Maestas. Aliyah was the Student Body President, National Honor Society Historian, a student mentor, Jaguar band member, and a reader for the Road to Literacy Elementary Reading Program. In her spare time, she liked to organize school activities and study. After high school, Aliyah plans on attending UNM to study elementary education. Aliyah was chosen by the staff at Valencia High School because of her high energy, her academic success, and her commitment to the student body. She demonstrated daily the skills to be an outstanding student and role model at VHS.

Aliyah thanked the Board and Ms. Chavez for the opportunity to speak to them about

Valencia High School. She then gave the following report:

Aliya said she was a member of VHS marching and concert bands, historian for the National Honors Society Chapter and also the acting president of Student Council. As such, she visited a lot of schools around New Mexico and could really can say that Valencia High School was the perfect place for her. With its beautiful view of the mountains, its spreadout and open campus, all the activities and clubs to join, and the amazing staff, it was exactly what she wanted in a school.

Valencia High School valued rigorous and top-notch education. At their Open House in August, they recognized and awarded all of their students who earned a 3 or higher on AP exams last Spring. Their AP class numbers were even higher this year and they were hoping to raise their AP exam scores to a new record!

Valencia High School partnered with Los Lunas Schools in the mentorship program. She was honored to mentor a student at Desert View Elementary. She went there every day to work with her. She loved getting to help her learn and grow and the program allowed her to see what it would be like to work in the field of education, which she hoped to do someday.

A. Student Representative Report: Aliyah Romero, Valencia High School

Aliyah stated that this year she was the student body president for Valencia High. As president, she helped build their student council and continue making school improvements that impacted their school and community. This fall, their council had hosted two school spirit assemblies, led student sections at sporting events, like our home football and volleyball games, and hosted literacy nights for the community. Student Council provided Seniors with a beautiful Senior Sunrise event and hosted spirit week and Homecoming events leading up to their WINNING their Homecoming Football Game on October 6th.

Student Council had also helped host the Road to Literacy Events. At their football literacy night on October 13th, she'd read a story to elementary students and their families on the jaguar logo out on their football field prior to the game. They gave away books and hot chocolate. It was so fun to see kids and their families excited about reading! At their volleyball literacy night, they enjoyed members of the 501st regiment who were dressed in Star Wars garb. They gave away comic books, did arts and crafts, and read with elementary students. For each of these events, StuCo got donations of books and comic books and

organized volunteers. VHS had about 30 Road to Literacy High School Students who went to elementary schools once a week to read with students in their assigned class. It was wonderful to know that they were helping young kids learn to love reading!

Aliyah stated that Valencia had a wide variety of activities, sports, clubs, performance arts, and NMOST. Their football team showed a lot of growth this year and made it to the first round of state. Their volleyball team was currently ranked at 2nd place in the district. They had three cross country finalists moving on to state - one, Victor Ramirez, took first place in the district male bracket. FFA was always competition ready, their 3 members in cross-country were going to state, Drama just had their second annul haunted house and it was a great success. Marching band took second place in the NAU Marching Competition, and their National Honor Society was working hard to gather donations of warm weather clothing and toiletries to share with individuals in the community who are in need this winter.

A. Student Representative Report: Aliyah Romero, Valencia High School

Aliyah said that one of the reasons she loved Valencia High was that the staff listened to the students. Last year the principals and student body president and representative began the "Principal's Advisory Committee." This was where the principals talked with the student body about what could be better and ways to improve the school. They also continued it this year and she could honestly say that the staff was truly listening to the students. Because of those meetings, new doorbells were installed to help improve student safety and student council worked together with staff to host community events.

The staff and coaches were able to make this happen for the students, they nurtured and created bonds and assisted and the students with the extra-curriculars, there were opportunities that staff and coaches provided.

Valencia was growing every year, making sure that it enhanced the experience for the students. The Valencia staff worked hard, the janitors worked hard to keep their school clean, their office staff works hard to make sure their school was in order, their teachers work hard to make sure that the students got the most optimal learning and that they were being recognized for their work. B. School Report: Amy Viramontes, Principal, Peralta Elementary

The board members individually commended Ms. Viramontes on her presentation, and it was noted that the school had a very strong support and participation from the parents and the community as a whole. Discussion ensued regarding various aspects of the presentation, during which Ms. Viramontes was asked to provide more information on the following areas:

- PLC professional learning committees because it was a small school, often included more than one grade level which increased collaboration
- AMIRA fairly new app using AI allowed to read at their level and gave feedback
- Merge Cubes app that used a cube that went under their iPads and assisted students to see more information on a subject example studying the heart cube could be turned and would show the different heart chambers the students really liked using them
- ROCKETLive! Safety Videos series of videos currently on bullying video. Mr. Vickers asked if they had one on gun safety. Ms. Viramontes stated that she didn't know the answer to that. He knew there was curriculum out there that dealt with that and thought that would be an important lesson for students to learn.
