SERVICE ANIMAL REQUEST FORM

(POLICY IDDFA)

The Calcasieu Parish School Board prohibits discrimination against individuals with disabilities, including those who are assisted by a service animal as result of a disability. The School Board shall comply with the requirements of Title II of the Americans with Disabilities Amendments Act of 2008 (ADAAA) and its implementing regulations, as well as other applicable federal and state laws and regulations governing the use of service animal by students and staff with disabilities in its services, programs, and activities. This form identifies criteria to help the District address some issues associated with animal in the educational environment. An individual with a disability requesting to be accompanied by a service animal for the purpose of participating in School Board programs services, and activities must follow the following procedures:

- 1. This form must be submitted to the District 504/ADA Coordinator at the address below at least ten (10) school days before bringing an animal onto School Board premises or participating in School Board programs, services, or activities.
- 2. Upon final approval from the superintendent or his/her designee, the District 504/ADA Coordinator will contact and send a copy of the approved request to the person requesting permission and the building/school administrator.
