(b) Maintaining control of his or her person and the equipment used. (c) Refraining from acting in any manner which may cause or contribute to death or injury to himself or others. 4. Failure to comply with the requirements of this paragraph shall constitute negligence by you the participant. 5. Inappropriate conduct by me or participant(s) may result in immediate expulsion from the program. 6. Ramp Up LLC is not responsible for personal items that are lost, stolen, or damaged.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Ramp Up LLC from any and all claims, demands, or causes of action, which are in any way connected with participation in this activity or use of Ramp Up LLC equipment or facilities, including any such claims which allege negligent acts or omissions of Ramp Up LLC.
