Title I Parent Involvement Plan

## G.W. Trenholm Primary School agrees to implement the following statutory requirements:

#### **Policy Involvement:**

- (1) An annual meeting will be held in September, to which all parents of participating children shall be invited and encouraged to attend. This meeting will inform the parents of the school's public participation under this part and to explain the requirements of this part and the right of the parents to be involved. A copy of the Parent Involvement Policy will be distributed and discussed. An opportunity for parent input/discussion will be provided.
  - (2) The annual meeting as well as other parent meetings will be held both morning (7:30 a.m., 9:00 a.m.) and evening (5:30 p.m.) as well as include a virtual option. Parents will be informed of the meetings through notices sent home with students, classroom app reminders, social media posts, and digital newsletter reminders.
- (3) Parents will be involved in planning, reviewing and making improvements in the G.W. Trenholm Parent Involvement Plan. Additionally, parents will be involved in the development of the Title I Program plan. At least three (3) parents, representing the grade span will participate in this process.
- (4) Parents of participating children will be provided information about programs under Title I through fact sheets and powerpoint presentations.

Parents will be given an explanation of the curriculum used at the school, methods and forms of assessment to measure academic progress, and the expected proficiency levels the students are expected to meet. This will be done at a parent meeting held early in the school year.

Through an ongoing needs assessment and program evaluation, parents will be given opportunities at regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and to respond to any such suggestions as soon as possible. An end-of-year needs assessment will be distributed. The results of this assessment will be used in revising the parent involvement policy.

(5) Should the Title I program plan be unsatisfactory, to parents of participating children, parent comments will be made available to the local education agency and / or the Alabama State Department of Education.

#### **Shared Responsibilities for High Student Academic Achievement:**

(6) A parent-school compact, specific to G.W. Trenholm Primary School, will out line how parents, the entire school staff and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the State's high standards. This compact will be distributed at the annual meeting.

### **Building Capacity for Involvement:**

- (7) Assistance in understanding such topics as STAR Reading, Math, Early Literacy, and CBM, Gold Strategies, ALAKIDS, ACAP, ESGI, Collaborative Classroom Assessments and other state-mandated assessments will be provided in a parent meeting as well as ongoing conversations with the school staff. Also, the take home folders will be used as a communication tool. This parent meeting will be held in the fall of each school year.
- (8) Materials and training will be provided to help parents to work with their children to improve achievement. Topics will include literacy and math training and using technology, as appropriate to foster parental involvement. The school entryway will provide handouts and reading materials on topics of interest.
- (9) Through regular meetings and communication with the principal, teacher and Title I staff, the value and utility of the contributions of parents will be realized. Stronger ties between home and school will be the result of frequent communication with parents.

(10) A collaborative effort will be made with the Sheffield-Tuscumbia Head Start Program, to transition parents into a continuing role of volunteering in their child's classroom. A transition meeting is held in March of each year. Head Start children entering kindergarten are invited to "Tour Day" following

registration. The Preschool program serves as a "stepping stone" into kindergarten. The preschool parents and students are invited to participate in all regular school activities. Additionally, GWT now houses two OSR First Class PreK programs that serve 36 students. This program will provide students with a smooth transition between preschool and kindergarten.

(11) All information will be sent home in a language the parent can understand. TransAct will be utilized to distribute forms, etc. to non-English speaking parents.

(12) Other reasonable support for parent involvement requests may be provided through this section. Notification of teachers' qualifications and/or parapro-fessionals' qualifications will be provided to parents. This *Right to Know* form will be distributed to parents and will be placed on the school system's website. system's website.

### Accessibility:

(13) To the extent practicable, full opportunities will be provided all parents, regardless of English proficiency, disabilities, and migrant status. Every effort is made to accommodate parents with disabilities. G.W. Trenholm Primary is a handicapped-accessible building. Plans are in place to serve homebound parents as needed.
