### 4. ANNUAL BREAKFAST SURVEY

The Annual School Breakfast Program Survey of elementary schools was conducted in March and the results have been tabulated. For the State to grant a waiver for the program, a response rate of at least 33%, with 80% of those children indicating a lack of interest in the breakfast program is necessary for the State to grant a waiver to the District. As the Board is aware, the District received waivers for 1995/96 through 2022/23 school years, based upon a low parental interest in conducting a school breakfast program. The results received this year revealed a 61% response rate at Munsey Park with 85% of those responding indicating a lack of interest. At Shelter Rock the response rate was 39% with 93% of those responding indicating a lack of interest in the program. Based upon the lack of parental interest in a breakfast program, the District should apply for a waiver from the State.

**MOTION:** The Board of Education for the Manhasset UFSD authorizes the President of the Board of Education to request an exemption from the State Education Department for the requirement to operate a breakfast program for the 2023/2024 school year.

### 5. Approval of a Private School Instructional Services Agreement (Enclosure)
