I. STATEMENT OF PURPOSE

The **HUBERT R. HUDSON ELEMENTARY** provides support for online assignments and Traditional Instruction and the school is committed to providing quality education to every student in the district. III. ANNUAL TITLE I-A CAMPUS PARENT MEETINGS

HUBERT R. HUDSON ELEMENTARY will hold an annual Title I-A meeting for parents. This meetings will be held during the fall semester.
