## Presentation(s) -

Fall sports report was presented by Doug Jones, Athletic Director. He gave an overview of the fall season indicating how each team did in their respective seasons. Mr. Sacco asked about purchasing a portable scoreboard for modified field hockey. Mr. Jones also suggested consideration for a modified cheerleading team and coach for next year. There was also discussion on considering designating a head coach modified cross country, separate from the head coaching position at the varsity level. There currently is a head coach with an assistant.

Senior Class Trip was presented by Michele Babbie. Ms. Babbie explained the two options for a senior class trip. One that they have attended for several years and the other option is less travel time. - 2. Budget Calendar was distributed prior to the meeting and dates were reviewed.
- 3. Chess Club & Ski Club are two clubs that the high school would like to add to the extra-curricular activities. Mr. Wheelock asked Mr. Read, High School Principal and Michael Eisinger, teacher to share their insight on the clubs. Mr. Read spoke first on the ski club. There is no reason the middle school and high school could not attend ski resorts together. Depending on the number of participants, the need for an additional advisor could be considered. There is a great number of students interested in chess. Mr. Eisinger reiterated the interest is high with chess. Many students play in the library and he looks at the chess club as a time for students to interact. Mr. Eisinger would like to see this club to maybe compete with other local schools in the future should we consider having a chess club.
- 4. SRP Substitute Rates Mr. Wheelock shared with the Board the need to adjust the substitute pay rates for the various job titles in the School Related Professional's unit. One reason is to stay consistent with changes to minimum wage rates and another is to increase the rate to encourage people to consider subbing.
