



## **Chandler Intermediate School Parent and Family Engagement Policy**

4. **Chandler Intermediate School** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

  - Parent Conferences- Spring
  - Letters mailed home with assessment results
  - Call outs to parents
  - Posted on district website
  - Social Media Facebook Page
  - Parent Square
  
5. **Chandler Intermediate School** will, at the request of parents, provide opportunities for regular

meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

- Parent/Teacher Conference scheduled in the Fall
- Parent/Teacher Conference scheduled in the Spring

6. **Chandler Intermediate School** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

- Principal will send a letter to parents notifying of the change in both English and Spanish.

7. **Chandler Intermediate School** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- Principal will send a letter to parents notifying them of the change in both English and Spanish.

8. **Chandler Intermediate School** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments, the requirements of Part A,
- how to monitor their child's progress, and how to work with educators:

9. **Chandler Intermediate School** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- Instructions for homework sent home via communication apps
- Parent Family Fair Night

10. **Chandler Intermediate School** will, with the assistance of its parents, educate its teachers, pupil

services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
