23-24 Parent and Family Engagement Policy

5. BISD campuses will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Parent/Teacher Conference Fall
 - Parent/Teacher Conference Spring

6. BISD campuses will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - Campuses will send student scores and TEA parent portal information via ParentSquare and school website

7. BISD campuses will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- Principal will send a letter to parents notifying of the change in both English and Spanish.
8. BISD campuses will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph

9. BISD campuses will provide materials and training to help parents work with their children to improve their children’s academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

BISD campuses will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

11.
