2023-24 School Safety Plan

The Yreka Community Day School provides a clean, healthy academic environment for its students; policies and plans are in place to ensure the safety of our students. Fire drills are held once a month, earthquake drills once per quarter, and we have an emergency disaster plan. We are in regular communication with the Yreka Police Department regarding traffic, safety, and situations in which we need assistance. Our Safety Committee conducts monthly safety inspections.

Our School Safety Plan was developed and written after extensive training for the staff and parents. The School Safety Plan was last reviewed, updated, and discussed with the school faculty in September, 2023.

We are committed to ensuring the safety of our students. The current plan addresses the following issues:

- Current status of school crime
- Child abuse reporting procedures
- Disaster procedures
- Suspension and expulsion procedures
- Teacher notification of student behavior
- Sexual harassment
- Board policy dress code

Students arrive at 8:00 A.M. and immediately begin working under the direction of the classroom teacher and a paraprofessional. During recess, the teacher or the paraprofessional is always outside with the students. At 3:00 P.M. our students leave campus to return home.
