** Security fees are degressive according to the number of enrolled children: 150€ for the first child, 100€ for the second and no charge for the third one.

An Advance Tuition deposit will be required to confirm the enrollment or reenrollment of the student. This Advance Tuition deposit is only refundable in the event of a documented force majeure. In all other cases, the Advance Tuition deposit is non-refundable. In all cases, the application and Development fees are non-refundable.

Should a student enrolled for the full year withdraw from the school at any time after confirming enrollment / reenrollment or during the course of the school year, whether it be at the initiative of the Family (voluntary departure) or of the School (dismissal for disciplinary reasons), the full annual tuition is non-refundable. Please note, the school may consider an exceptional partial tuition settlement with the family in demonstrated force majeure cases, or for compelling and legitimate reasons such as serious illness impeding the student's continuation in school or unexpected transfer out of the Paris area by employer.

For changes in Student Life Option from Boarding to Day student, the annual boarding fee will be due, and no refund will be considered for the year. The school may consider an exceptional partial tuition settlement with the family in demonstrated force majeure cases, or for a demonstrated compelling and legitimate reason.
