Pursuant to Personnel Commission Rules & Regulations 70.200.1: "...a new employee may be granted advanced step placement upon recommendation of the appointing authority and approval by the Director of Classified Human Resources, subject to ratification by the Personnel Commission."

Personnel Commission staff recently filled a vacancy in the Facilities department for the Grounds Manager position. Mr. Marc Gilpin was selected for the position by the hiring authority, the start date is January 30, 2023. Mr. Gilpin is being recommended to start at Step 2 of the Grounds Manager classification on the Classified Management salary schedule based on the following:

• Experience – Approximately 15 years' experience in school grounds management.

Experience as the Grounds Manager at Fresno Pacific University from November 2007 to present.

- Additional skills or qualifications Mr. Gilpin has more years of experience and higher-level experience than what is needed for this position and can lead a grounds department.
- This would also be considered a hard to fill recruitment.

The minimum qualification for the Grounds Manager position are:

- Education Graduation from high school or equivalency. Specialized training in industrial and landscape maintenance, irrigation systems, horticulture, or a closely related field is desirable.
- Experience Five years of grounds maintenance experience which includes experience performing or overseeing all of the following: grounds landscaping and maintenance, irrigation systems, and landscape construction and installation. At least two years of the aforementioned experience must have been in a supervisory or lead capacity.
