Mrs. Nair-Villano gave an update on current recruitments and classification studies. She Director's Report summarized the Commission's staff activities as of the last Commission meeting. Ms. Poland reported on the bargaining team attending an upcoming healthcare symposium Report by CSEA in Pasadena on September 27. Ms. Poland and the bargaining team continue to make site visits; few sites visited recently include Kamala, Harrington and San Miguel. Ms. Poland commented that she continues to work along with Classified HR staff and gave thanks to Tanya Ventura, Administrative Assistant for going above and beyond in her efforts to support the Classified service. Dr. Bond reported on the continued partnership with California State University, Channel Report by Assistant Islands on the Teacher Residency Program. This is a great opportunity for current Superintendent, employees with tuition reimbursement, stipend and residency offered. Currently five Human Resources and candidates from the District are participating in the program. Dr. Bond informed and invited the Commissioners to some upcoming events: Marshall School grand opening on Support Services September 11, Lemonwood School grand opening on September 25, and the 8th Annual Strengthening Our Families event at Haydock School on September 21. Commissioner Castillo commented on missing the Marshall School grand opening due to Report by the mailed invitation arriving late. He shared his participation on the oversight committee Commissioners for the Marshall construction and regrets he was not able to attend. Commissioner Robinson apologized he was not able to attend the Marshall School grand opening due to a conflict and expressed interest in attending the Lemonwood School grand opening. Commissioner Robinson expressed that he was very happy to hear about the partnership with CSU Channel Islands. The Commission convened into closed session at 5:14 p.m. They reconvened into open CLOSED SESSION session at 5:47 p.m. and reported that no action was taken.
