We are a TK-5 elementary school located in the City of Morro Bay. The school overlooks the Pacific Ocean to the west and the Santa Rosa and Coastal Range of mountains to the east. The Del Mar school community focuses on the academic, social, and emotional success of every student. The school meets the needs of all learners through strong core academic programs in language arts and math, highly developed intervention programs for at-risk students, as well as opportunities for acceleration. Our K – 5th-grade students have open access to our amazing iINNOVATE lab and the STEAM-centered activities there. Our school partners with Children's Creative Project to provide art lessons in our K-5 classes. Students have opportunities to participate in activities such as Student Council, Drama Club, Chess Club, Spanish Club, Running Club, Variety Show, and Noontime Sports during a typical school year. ## SCHOOL FACILITY CONDITIONS AND PLANNED IMPROVEMENTS

### Facility Conditions and Planned Improvements

The District extends great efforts to maintain the schools in a manner that ensures that they are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument, with all potential problems related to safety reported and monitored for completion by site administration and the Building, Grounds, and Transportation Department. Elementary and middle school planned improvements include accessibility upgrades, campus-wide painting projects, fire alarms, and parking lot paving.

The following is specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, functional learning environment.

### Age of School Buildings

Del Mar has 27 classrooms, a multipurpose room, a library, and an office. The main campus was built in 1961; additions were constructed in 1966 and 1997.

### Maintenance and Repair

The District maintenance staff ensures that repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is utilized to ensure efficient service and ensure that emergency repairs are given the highest priority. Many of our facilities are being modernized as part of the District Measure D program enacted in 2014.

### Cleaning Process and Schedule

The Board of Education has adopted cleaning standards for all schools in the district. A summary of these standards is available at Buildings, Grounds and Transportation. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

### Deferred Maintenance Budget

The district utilizes a deferred maintenance plan that is funded by an annual percentage from the District general fund. The District uses the funding to assist schools with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems.

## B. PUPIL OUTCOMES

### Pupil Achievement

3. **California Science Test (CAST) and CAAs for Science** in grades five, eight, and once in high school (i.e., grade ten, eleven, or twelve).

**College and Career Ready:** The percentage of students who have successfully completed courses that satisfy the requirements for entrance to the University of California and the California State University, or career technical education sequences or programs of study.
