EXTENDED DAY

Before Care

The *Before Care* program allows children to start their day on campus as early as 7:00 a.m. *Before Care* is held on the Fontbonne Campus and operates every day school is in session, beginning with the first full day of school. Children are transported by shuttle van from the Fontbonne Campus to the Norwood Campus for the start of the academic day.

After Care

The *After Care* program provides extended care for students, age three to grade 6, from 3:00 to 6:00 p.m. *After Care* is held on the Fontbonne Campus and operates every day that school is in session, beginning with the first full day of school, except when there is a noon dismissal. Children are transported via school shuttle from the Norwood Campus to the Fontbonne Campus at the end of the academic day.

PAYMENT OPTIONS 2024 - 2025

Payments are made to Tuition Aid Data Services (TADS), which is a convenient and user-friendly online tool where families make tuition and fee payments.

One-Pay Plan July 1

PAYMENT METHODS

Pay TADS by check, money order, bill pay, pre authorized debit from a checking or savings account, or by credit card. There is a convenience fee assessed on all electronic payments.

TUITION ASSISTANCE

Tuition assistance is renewable and families are required to apply each year. The amount of tuition assistance available each year is contingent on the number of families applying, the amount of funds available and the demonstrated financial need of each family.

Applying for tuition assistance does not affect your child's chances of admission. The processes are simultaneous, but separate. That said, each family also bears the primary responsibility for completing all necessary steps of the tuition assistance application.

CONTINUOUS ENROLLMENT CONTRACT
