a. N. Main Veterans Park, Proposed Memorial

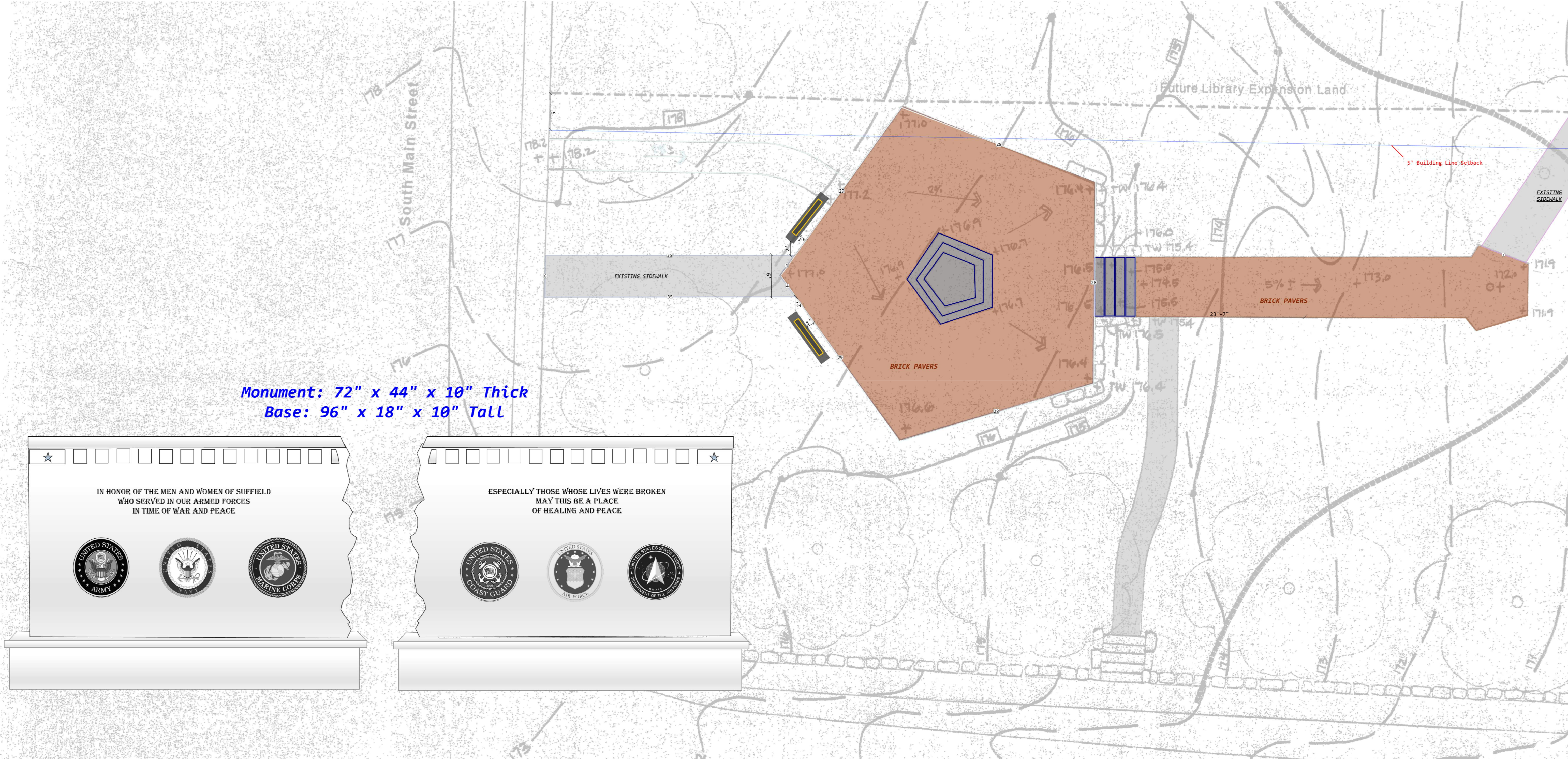
Chairman Mayne gave a brief overview of the discussion that occurred at the January 8th Regular Meeting and shared all of the updated diagrams provided by Mr. Gauthier. He explained that this version included a two-inch reduction to the base and a four-inch reduction to the top piece, which will lower the entire monument by 6 inches. In addition, Mr. Gauthier adjusted the placement of the monuments and moved them an additional foot on either side of the sidewalk. The diagrams being reviewed this evening also illustrate a straight edge on the base of the monument and the Space Force emblem, which were changes requested at the January 8th meeting. All members of the commission were satisfied with the plan presented by Mr. Gauthier this evening, which included a 44 inch tablet height and 10 inch base with straight sides. Discussion ensued as to how best to word the motion and a decision was made to attach the approved plan to the minutes.

Mr. Schwemmer motioned and Ms. Quandt seconded to approve the application for the war memorial at the Veterans Memorial Park, which includes the revision reviewed today with the 4'.5" foot total height and the base with the unbroken edge. (Plans attached.) Vote: 5-0 in favor. Motion passed unanimously.

Mr. Schwemmer motioned and Ms. Moore-Manwaring seconded to adjourn at 6:23 p.m.
