Approval Request

Lacomb Roof- Upon careful review Administration requests approval of ABC Roofing as low bidder in the amount of \$1,644,172 for Lacomb elementary school wing roof replacement. See attached information for additional bid information.

LHS Cafeteria Equipment- Administration requests approval of Curtis Restaurant Equipment as low bidder in the amount of \$347,014.00 for new LHS cafeteria equipment. See attached information for additional bid information.

LHS Cafeteria Contractor- Administration requests approval of First Cascade Corporation as low bidder in the amount of \$141,580.00 for LHS cafeteria construction. This approval request includes an approval of an intermediate procurement increase in compliance with OAR 137-049-0160 (6)(b) which reads: Up to an aggregate Contract Price increase of 50% over the original Contract amount, when a Contracting Agency's contracting officer determines that a price increase is warranted for additional reasonably related Work and a Contracting Agency official, board or governing body with administrative or review authority over the contracting officer approves the increase. LCSD went out for quotes based on an initial contractor estimate of under \$100,000. We used an intermediate procurement process based on this estimate. With the final bid coming in above this amount we need to approve a 50% increase based on OAR 137-049-0160 (6)(b) to follow state procurement laws.
